

JAMUL DULZURA UNION SCHOOL DISTRICT FACILITY USE FEE SCHEDULE

Organizations wishing to use the Jamul-Dulzura Union School District Facilities and/or Grounds must submit a Facility Use Request Form and applicable supporting documents. The Form and supporting documentation must be turned in at the District Office, to be approved before use of facility or grounds is permitted. Once approved (and if applicable fees or charges have been paid) a Use Permit(s) will be issued to requester for the term of use.

FEE SCHEDULE:

FEE SCHEDULE: USE FEES ARE BASED ON FAIR SHARE COSTS OF THE OPERATION AND MAINTENANCE OF DISTRICT FACILITIES AND GROUNDS AS PER THE CALIFORNIA CIVIC CENTER ACT (EDUCATION CODE SECTIONS 38130 ET SEQ).

“Existing law, known as the Civic Center Act, authorizes a school district governing board to grant the use of school facilities or grounds as a civic center, for specified purposes, upon terms and conditions deemed proper by the governing board. Existing law authorizes a school district governing board to charge a fee, not to exceed the school district's direct costs, as defined, for use of the school facilities or grounds by entities that promote youth and school activities or that arrange for and supervise sports league activities for youths.”

Governmental Agencies may be exempt from fees at the discretion of the Superintendent's Office

JAMUL DULZURA UNION SCHOOL DISTRICT FACILITY USE FEE SCHEDULE

- SNACK BAR & RESTROOM: FOR JAMUL LITTLE LEAGUE AND AYSO ONLY-FOR THE MONTHS THEY REQUEST USE, THEY WILL BE BILLED THE ACTUAL COST OF ELECTRICTY AND TRASH. PAYMENT IS DUE WITHIN 30 DAYS OF INVOICE.
- DAMAGES: ANY DAMAGES INCURRED DURING USE OF FACILITES WILL BE DIRECT BILLED TO USER AGENCY.
- CANCELLATION: MUST BE GIVEN TO THE DISTRICT OFFICE 48 HOURS BEFORE THE DATE OF THE INTENDED USE IN ORDER TO AVOID FINANCIAL OBLIGATION FOR CHARGES.
- USE PERMITS: FACILITY USE PERMITS MUST BE CARRIED BY THE RENTER AT ALL TIMES WHILE ON DISTRICT GROUNDS AND MUST BE PRESENTED ON DEMAND. FAILURE TO PRESENT PERMITS UPON DEMAND MAY RESULT IN REVOCATION OF PRIVILEGES.
- PROOF OF INSURANCE: PROOF OF INSURANCE IS REQUIRED PRIOR TO APPROVAL OF ANY FACILITY USE – **NO EXCEPTIONS**
- THE CERTIFICATE MUST NAME THE JAMUL DULZURA UNION SCHOOL DISTRICT AS ADDITIONAL INSURED FOR ONE MILLION DOLLARS.
- NON PROFIT STATUS: MUST PROVIDE PROOF OF NON PROFIT STATUS PRIOR TO APPROVAL-THERE IS TO BE NO PIGGYBACKING OF NON PROFIT STATUS WITH ANOTHER ORGANIZATION WHICH HAS NON PROFIT STATUS.
