- \*\*If the student receives Special Education services, the school selected must have the Special Education services required by the current Individual Education Plan (IEP).
- \*\*\*The student must be in good academic standing (**must attach copies of last report card, attendance report and disciplinary report for application to be reviewed**).
- Acceptable grades, behavior and attendance must be maintained.
- Parents/Legal Guardians are expected to maintain a cordial and cooperative working relationship with school personnel.
- Parents/Legal Guardians are responsible for timely transportation to and from school. **NO BUS TRANSPORTATION** will be provided.
- **Upon transfer approval, the \$300 fee applying to non-resident students (students residing outside of the Bartow County School District) must be paid in full, before June 30, 2026. Once the initial \$300 tuition/student is paid, subsequent years will be \$150/student. In order to receive the subsequent year's lower tuition, all tuition must have been paid, in full, by June 30th of the previous year.**
- **A new application must be completed each year for out of district students.**
- If the student transfers at the high school level, he/she must meet the eligibility requirements of the Georgia High School Association to participate in competitive interscholastic activities. (www.ghsa.net)

**Applications received after 3pm on February 27, 2026, will not be considered.**
