Vision

The Hall of Fame has been established in an effort to recognize and honor individuals who have made a significant contribution to the traditions and reputation at Burdett, Rozel, and Pawnee Heights High Schools. Individuals recognized will have exemplified the character, ideals, outstanding skills, and commitment of excellence promoted in our schools and to give our youth a motivating influence for the future.

Hall of Fame Board of Directors

Appointed members to the Hall of Fame Board of Directors shall be:

1. The athletic director or appointed administrator.
2. Six dedicated community members of the Rozel or Burdett area or graduates of Burdett, Rozel, or Pawnee Heights High Schools.

Term of Office

The term of office for the board of directors will be on a two (2) year rotation. Two of the original six board members will serve two years and then be replaced. The following year, two more original board members will be replaced, and then the following year, the last two original board members will be replaced. The board members may not be selected for the board of directors for consecutive terms. There must be one (1) year between terms. The school board is responsible for appointing replacement members in the event of a member leaving before their term is finished. Appointed replacement board members will complete the elected member's term.

Nominations

1. Nominations can be made by anyone and are able to make multiple nominations.
2. Nominations need to be sent to:

3. Individuals making nominations must support the nominee with pertinent information, statistics, records and achievement.
4. Hall of Fame board members will consider all nominations.
5. Nominees not selected to the Hall of Fame must be resubmitted again the following year to be considered.
6. Nominations for the upcoming year must be turned in by January 15.
7. In the first round of voting, each board member will vote for their top five (5) nominees. Their top vote receives five (5) points, their second receives four (4)

points as so forth. Each nominee's points will be added up and the five (5) nominees with the most points will make the second round of voting.

8. There will be a maximum of four (4) inductees per year. Each board member may vote for a maximum of three (3) nominees. Nominee's will need four (4) votes to be inducted into the Hall of Fame.

Criteria for Selection

Athlete - The nominee, during, and following his/her career, has exemplified outstanding skills, character, and a commitment of excellence.

Coach - The nominee, during, and following his/her career, has exemplified role model characteristics as a coach. The nominee must have coached at Burdett, Rozel, or Pawnee Heights High Schools.

Team - The team must have been a state championship team or a team with very high achievement.

At Large - The nominee must have achieved a high level of achievement in one or two of the following.

1. Professional/Personal Life.
2. Community Service/Support of Burdett, Rozel, or Pawnee Heights High School.
3. Demonstrate education to be a lifelong experience(Teachers, Administrators, etc...)

The nominees will need a majority of four (4) votes by the Board of Directors to be inducted into the Hall of Fame. If the person nominated is on the Board of Directors, that person cannot be considered until he/she is not a member of the Board of Directors.

Amending By-Laws

These by-laws may be amended by a majority vote of the Board of Directors.
