RE: Fees to Processors of USDA Donated Foods for the 2026-2027 School Year

Each year, a school district in the state prepares, evaluates and awards a bid for the processing of USDA Donated Foods into end products. The Food and Nutrition Bureau of Health and Human Services then purchases and diverts the donated food to the companies for processing into end products which are returned to each district. A product show is held in November or December for districts to determine the products they wish to obtain and the bid provides the fee for service paid to the processor.

For the 2026-2027 School Year, Las Cruces Public Schools prepared the bid, and 32 companies were approved for use by New Mexico districts. After presentation to the Board of Education for Las Cruces Public Schools, award letters were sent to the approved vendors.

Santa Fe Public Schools has diverted donated food to 10 vendors and will be receiving product from those companies throughout the year to meet menu needs. Some of those products are ground beef, Mandarin orange chicken, glazed drumsticks and pizza.

The estimated purchases are \$209,232.07, which are paid from the Food Service Fund and covered by the USDA reimbursements for breakfast, lunch and snacks provided from August 7, 2026 through May 20, 2027.
