MHS World Language teachers, Joan Free and Jessica Frankovich, also presented to the Board members and guests. The principals concluded the presentation by sharing about MHSmart and the food pantry services available at the high school.

J.V.S. Delegate

Ms. Gray shared an update from Mr. Bradley on topics from the December 11 Great Oaks Board meeting, including that applications are now open for the 2025-2026 school year with videos available on the Great Oaks website detailing each program for families and students. The McClain student featured in the Student Spotlight was Lisa Vanzant, daughter of Jimmy and Ondi Vanzant. Lisa is in the Early Childhood Education program, and her job placement is at Tiny Town Childcare & Learning Center.

Treasurer's Report

Mr. Barber discussed the following items:

- A goal for the fiscal office was to reduce paper disbursement. Currently payroll is paying all but 5 payments (out of 43) electronically. The accounts payable office now has 131 vendors enrolled in ACH payments. This has allowed for quicker and more secure disbursements.
- The District received additional DPIA funding due to the CEP program. DPIA funding does require the Board to identify and post a plan for spending the funds.

Mr. Barber and Ms. Gray along with two staff members have identified the spending plan.


