September 8, 2025

The Edmond Board of Education, of Independent School District Number 12 of Oklahoma County Oklahoma, met in Regular session Monday September 8, 2025 at 6:00 PM at Edmond Public Schools Administrative Center, 1001 W Danforth Rd, Edmond, OK 73003.
