As most have received a letter from Maria Steele on a property she owns in Tulia. Prop ID 17327 located at 412 N Briscoe Ave. Just a little background on Ms. Steele: she purchased the property in 2023 and on her deed her address is listed correctly as she lived in Sherman County, not Sherman TX. The Swisher County Appraisal District put her address incorrect as the town Sherman, TX, so she never received her tax statement for 2023 taxes. I have visited with the tax Attorney's office, Perdue, Fielder, Collins & Mott and they have agreed to remove the attorney fees. She has to contact the taxing entities and ask the same for the penalty and interest as I do not have the authority to remove them. I have attached a statement of account for your review, showing penalty and interest and a statement that was mailed in 2023.
