Dear Credit Union Member:

If you will be graduating from one of NPTFCU's sponsor high schools in 2026, you may be eligible for one of the Northeast Panhandle Teacher Federal Credit Union scholarships. Please review the list below for eligibility requirements.

### SCHOLARSHIP CRITERIA

1. Student must be a member in good standing with the credit union. Membership must be obtained prior to May 1<sup>st</sup> of your junior year.
2. The scholarship will be used for the purpose of study at an accredited college, university, or vocational/technical school.
3. One-half of the scholarship funds will be paid to the recipient when evidence of enrollment is presented to the credit union and the remaining half will be paid to the recipient when evidence of successful completion of twelve semester hours is presented to the credit union.
4. Areas of consideration for selection will include academic achievement, character, leadership, and personal recommendations.
5. Recipients determined by the Board of Directors of Northeast Panhandle Teachers Federal Credit Union will be final.

If you qualify for participation, please complete the enclosed application and forward it and all other required documentation to the credit union. You must include your first three year transcript. If you have any questions, please contact the Credit Union at 806-435-9522.
