Yantis ISD Plan for Meeting Teacher Certification Requirements by 2029-2030

Pursuant to Tex. Educ. Code § 21.0032(a-1), Yantis ISD has created a plan to delay the full implementation of certification requirements for teachers of record in foundation curriculum courses until the beginning of the 2029-2030 school year.

I. LEGAL FRAMEWORK

This plan is created in response to the requirements of **Texas Education Code (TEC) §21.0032**, as enacted by **House Bill 2 (HB 2, 89th Legislature, Regular Session, 2025)**, which mandates that a person may not be employed as a teacher of record for a foundation curriculum course unless they hold the appropriate certification. While the statutory compliance deadline is the start of the 2029-2030 school year, Yantis ISD is committed to achieving this standard as rapidly as possible to ensure high-quality instruction for all students.

II. District Commitment

Yantis ISD is committed to fully phasing out uncertified staff in all core curriculum roles by the start of the 2029-2030 school year. This goal is supported by:

- Ensuring a strong EPP partnership that will promote and nurture avenues of certification.
- Ensure that all uncertified teachers have a certification plan in place.
- Assign mentor/campus leader to help encourage and track uncertified teacher progress to ensure they are meeting their certification deadlines.
- Support uncertified teachers through professional development at the ESC geared towards certification areas.
- Apply for the GYO and PREP Residency to build a pipeline of certified teachers through the LIFT Grant.
