11. All items shall be fully guaranteed free of all physical and material flaws and free of any engineering and/or construction defects for a minimum of one year from the date of acceptance

by the Tuscola Intermediate School District. Any repairs, replacement or adjustment expense involved under this guarantee is assumed by the vendor.

12. All bid proposals shall be signed by the legal company president or their designee.
