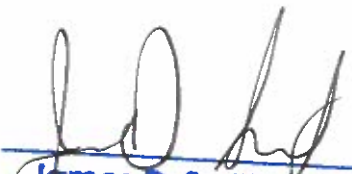
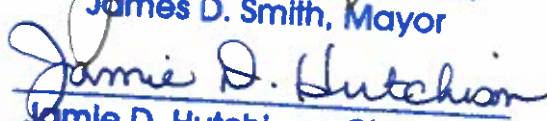
4. Adjourn
