APPOINT JOHN MERZ TO BOARD OF ADJUSTMENTS

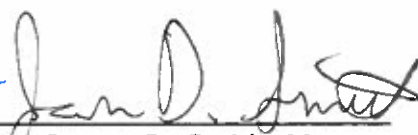
