**WESTERLY CREEK ELEMENTARY** is a neighborhood school that serves approximately 650 ECE through 5th grade students. There is one full-day ECE classroom for 4-year-olds, and four classrooms in each grade level in grades K-5th. In addition, the school has three Autism Center-Based classrooms.

The Westerly Creek Elementary (WCE) community believes that a love of learning, high academic achievement, and family involvement are the keys to a lifelong education. ## DAILY SCHEDULE – SCHOOL HOURS

- The first bell rings at 8:05 AM, and the second bell rings at 8:10 AM
- The dismissal bell rings at 3:10 PM
- Full-Day ECE 4: 8:10 AM– 3:10 PM
- Full-Day Kindergarten-5th Grade: 8:10 AM– 3:10 PM
- Faculty: 7:50 AM– 3:50 PM
- Office Hours: 7:30 AM– 3:30 PM

## ADULTS AND VISITORS ON CAMPUS

Your child's safety is our number one concern. With that in mind, all non-staff adults on campus must sign in at the office, through the main entrance (28<sup>th</sup> Avenue and Akron Street) and wear a volunteer badge, visitor badge, or visitor sticker. You may not enter or exit the building by any other doors. Whether you are coming to volunteer for several hours or are just dropping off a lunch, you must sign in at the office first. The volunteer and visitor badges and stickers serve as a visual ID that lets staff members know immediately who is authorized to be in the school and reinforces our commitment to keeping children safe.

ECE and Kindergarten families must also adhere to these rules, except for arrival and dismissal times. ECE and Kindergarten classrooms will be inaccessible via the outside classroom doors during school hours.

## ARRIVAL, DISMISSAL AND EARLY DISMISSAL

**ARRIVAL:** The school day begins promptly at 8:10 AM for all students. Students should NOT arrive before 7:50 AM (unless they are having breakfast with a parent or guardian in the cafeteria which begins at 7:30 AM or on their own, which starts at 7:40 AM), as no adult supervision is

provided on the grounds. Children are **NOT** permitted in the building before the beginning of school, as teachers are busy preparing for the day's lessons. K-5 students are required to report directly to the playground or their designated meeting area, where they are supervised by staff from 7:50 AM until 8:05 AM. When the bell rings at 8:05 AM, students will be asked to line up at the classroom doors or in front of the designated entrances to the school.

**Morning arrival in cases of inclement weather (8:00 AM - 8:05 AM)**

- ECE – Students must be signed in by a parent or guardian daily in the classroom. Please park in the east parking lot on Akron St.
- K-5th Grade – Students report outside of their classrooms in the hallway.

Please help remind your child of this change on inclement weather days to ensure a smooth morning for both staff and students. On cold (below 20 degrees F), rainy or snowy days, children should dress appropriately and should **NOT** arrive at school until 8:00 AM, unless they are eating breakfast at school.

**WHEN STUDENTS ARE TARDY:** Please notify the school if your child will be tardy by accompanying your child to the office, leaving a message on **the attendance line at 720-424-3168**, or writing a note for your child to deliver to the office in order to officially excuse your child's tardy. A tardy is unexcused if, on the day of the tardy, no valid reason is given by either a phone call or note from a parent or guardian to the office.

Students arriving after the 8:10 AM tardy bell should be accompanied by a parent/guardian, and must report to the office before going to class. All absences and tardiness become part of a child's permanent record file. Please see the **Attendance and Absenteeism** section for more information on the school's attendance policy.

**DISMISSAL:** For all students in ECE through 5th Grade, dismissal begins when the bell rings at 3:10 PM. Faculty members supervise the building exits during dismissal, and there is no playground supervision after school hours.

Children who are not picked up by 3:15 PM will be asked to wait for parents/guardians by the main office. The Department of Human Services will be contacted for children waiting after 3:45 PM.

**PLEASE WAIT FOR THE 3:10 PM BELL.** In order to maintain student safety and building security, please do not enter the building before the 3:10 PM dismissal bell. If you have a pre-scheduled

event or appointment that requires you to pick up your child before 3:10 PM, you are required to show a valid picture ID at the front office in order to sign them out.

**MAXIMIZING STUDENT TIME IN THE CLASSROOM IS ESSENTIAL.** It is important to every child's success to fully maximize their time in the classroom by minimizing interruptions. When the front office is asked to make a call to a classroom, it is disruptive to quality learning time and instruction. We kindly request the following:

1. Please do not pick up your children early from school unless absolutely necessary. Please wait for the 3:10 PM bell.
2. If you must pick up your children early, we will call the student down from class when you have arrived in the office. Teachers have been instructed to wait for your arrival **and** a call from the office before sending students to the office. Please allow extra time when planning early dismissals.
3. Additionally, please communicate with your children and their teacher(s) before school about their dismissal routines if it happens to change regularly (e.g. varying between bus, parent/guardian pickup, Discovery Link, etc.).

**EARLY DISMISSAL:** It is strongly recommended that all appointments and extracurricular activities be scheduled outside of school hours as the loss of class time is detrimental to students. In the event that the occasional appointment cannot be so scheduled, a note or email should be sent to your child's teachers informing them of the early dismissal for that day and giving the time that the parent/guardian will pick up the student. Parents/Guardians must report to the front office to officially sign them out of school before students will be called from class. A valid photo ID is required, no exceptions. Teachers are instructed not to release children from the classroom, lunchroom or playground without official authorization from the office. This procedure is followed to protect your child and to hold classroom interruptions to a minimum. A child will not be released to anyone who is not listed in their file or to anyone under 18 years of age, unless the school's office has been notified in writing by the parent/guardian. Parents may also add additional contacts through the parent portal.

**MISSED SCHOOL WORK:** Students are responsible for handing in all work due in the classes they will miss and for completing any assignments for the following day.

Should early dismissal become necessary because of an illness or accident in school, the nurse/office will contact that parent/guardian or appropriate designee on the Emergency Information Form. A parent/guardian or emergency contact person must sign the student out of school as outlined above. A doctor's note may be required if absences or early withdrawals are deemed excessive (please see the **Attendance and Absenteeism** section for more information).

## ATTENDANCE AND ABSENTEEISM

In order for students to receive the full benefit of the school day, daily attendance is the first and most important step. The school calendar is published and distributed before the commencement of the school year and parents/guardians are asked to schedule any travel within the dates that classes are NOT in session.

Please notify the school if your child will be absent or tardy by phoning the school attendance line at **720-424-3168**. This should be done each day a child is absent.

Academic work may be made up for approved absences. However, please do not drop in at dismissal time to request work. Requests should be made via phone or email ahead of time directly to your child's teacher.

WCE has an attendance and tardy policy in accordance with the Colorado School Attendance Law and Denver Public Schools' Denver Plan [ <https://www.dpsk12.org/attendance/> ]. These guidelines allow for roughly 10 absences during the course of a school year or in other words, a 97% attendance rate. Every month, the school reviews student attendance and sends letters to parents/guardians for those students whose absences are excessive. The definition of "excessive" changes throughout the school year based on the number of school days, but parents/guardians can expect to receive the first letter after 5 absences or 5 tardies.

Once a child's absences have reached a level of concern, which is currently 10 absences/tardies or more (please note that this is outside of medical or family emergencies), an attendance contract must be completed with the school. This will outline attendance expectations as well as the additional requirement of a doctor's note for any absence of two days or more. If absences are chronic, excessive, unexcused, or otherwise of concern, a child and their family will be referred to truancy court where the court will mandate your child's attendance. This mandate is quite serious and will follow the child for the remainder of their education. A few other things to note are: A school principal can 'un-excuse' any parent/guardian-excused absence if a student has become truant. Excessive tardies and early withdrawals are also subject to truancy law.

## BIRTHDAY SNACKS AND CELEBRATIONS

As some grade levels have developed their own ways of celebrating birthdays, please reach out to your child's homeroom teacher to learn more.

If the celebration includes treats, all treats must be store-bought and have a printed list of ingredients so the teacher can read them. Since we have a number of students with severe

allergies in some classrooms, we ask that you check with the classroom teacher to see if any special considerations need to be honored. Parents/Guardians that have students with severe allergies are asked to provide an alternative snack that the classroom teacher can use as a substitute, when needed. Please be mindful of treats, and we encourage providing only bite-sized options.

## BUS TRANSPORTATION

Students who live at least one mile from the school are entitled to school bus transportation by DPS [ <https://transportation.dpsk12.org/> ]. The routes are set by the district and any questions concerning this service should be directed to the transportation office. For the safety of each child, it is always a good idea to walk your children to and from the bus stops. Younger children should always be escorted or picked up by an adult or a responsible sibling. For information regarding late buses, or any other bus questions, call the parent/guardian hotline number at **(303) 825-2611**. Please report any problems, concerns or questions to the school office.

Regarding **bus behavior**, it is important that children obey bus safety rules. When students misbehave, it is difficult for the bus driver to concentrate on driving. To ensure the safety of students riding the bus to/from school or on excursions, please remind your students that they:

- Must sit in their seats quietly
- Must enter and exit the bus in an orderly manner
- Must keep head and arms inside the bus
- Must refrain from eating on the bus
- May not change seats or stand while the bus is in motion

## CANCELLATION OR DELAY OF SCHOOL

Check the DPS Weather Delay page [ <https://www.dpsk12.org/page/weather> ] and listen to the local television and radio stations for school closures or delay announcements. KOA 850 or KBNA 1220 are the official announcement stations for school closing information. DPS is committed to informing families about school delays or closures as early as possible with the goal to make the call by 5 a.m.

In the unusual circumstance where school must be canceled during the school day, parents and/or guardians will be notified immediately. The information on file in the office will be used, and school staff will determine that all students have satisfactory transportation and supervision at home before releasing them from school. Please make sure your emergency contact numbers are kept up-to-date to ensure that we may make timely contact with you during the school day.

## CELL PHONES AND ELECTRONIC DEVICES

WCE prohibits students from using and carrying cell phones/smart watches during the school day. These interfere with instruction and may impede school safety in an emergency. If you wish for your child to have a cell phone in his or her possession for reaching you after school, your child may keep it in his or her backpack at all times during the school day. Students may wear smart watches during the day if they are kept on school mode. If a child is out of compliance with this policy, cell phones/smart watches will be confiscated by the teacher or other staff member. Parents/Guardians must then pick up the cell phone/smart watch from the school.

**Please note that WCE is not responsible for any lost or stolen items; please see Toys and Personal Belongings section for more information.**

## CLASS PLACEMENT PROCESS

WCE hires and retains the best teachers in the district. Assigning students to classes is most effectively done by our classroom teachers who have been working with the students daily in an educational setting. Teachers consider the learning styles and academic needs of the returning students and assign them to classrooms at the next grade level. This process is done with care and the utmost consideration of each child's academic and social/emotional needs. It takes into consideration many factors: academic needs, behavior, gender, ethnicity, and number of students to create equitable and balanced classrooms.

## COMMON AREA AND PLAYGROUND

In order to maintain a positive school culture and student safety, we have several school-wide expectations for students in our common areas and on the playground.

In hallways/common areas, students:

- Always walk.
- Form 2 lines, when traveling with classmates.
- Keep hands and feet to selves.

On the playground, students:

- Skip, walk or move carefully on blacktop.
- Sit down on the slides.
- Only throw objects meant to be thrown.
- Use the swings and other equipment properly.
- Remain on the playground at all times.
- Treat others with respect at all times.

## COMMUNICATION EXPECTATIONS

The Main Office telephone number is 720-424-3160. Hours of operation are from 7:30 AM until 3:30 PM. Messages can be left after hours.

WCE will communicate primarily through e-mail to families. Families will automatically be subscribed to receive regular correspondence from the school and also from their child's grade level teachers on a weekly basis.

Teachers are expected to communicate with parents/guardians regularly regarding your child's academic progress. These forms of teacher communication include and are not limited to classroom weekly updates (blogs, emails, etc.), parent-teacher or student-led conferences (twice yearly), report cards (each trimester), and informal and formal communications, as needed. If you have questions or need more information from a teacher on your child's progress, please contact him or her directly via email or phone to schedule an appointment. WCE encourages parents and guardians to communicate their concerns to the appropriate staff first, before contacting the principal's office. However, parents and guardians are welcome to involve administration if and when it is warranted.

## COMPUTER/INTERNET/TECHNOLOGY

All parents/guardians and students must sign an *Acceptable Use Agreement* during registration governing computer use at WCE. Failure to comply with any or all of this policy will result in a loss of any or all computer use privileges.

WCE believes that the use of technology is integral to teaching students, and to this end Interactive Boards are used in every classroom from kindergarten through fifth grade. In addition, WCE has Chromebooks available for individual use in class for learning and testing throughout the school year. Student use is closely monitored with all technological tools.

## CONDUCT

WCE has adopted a positive behavior program that focuses on character qualities that include high standards of conduct and personal responsibility in our students each school day. We call these standards CREEK qualities:

C – Compassion | R – Respect | E – Empathy | E – Engagement | K – Kindness

Students are recognized for demonstrating the CREEK Kid Personal Success Factors in many ways each month. Students who are highlighted weekly have their names read in class during announcements. School-wide community celebrations are held to honor CREEK Kids monthly. Dates will be posted on the WCE calendar. Family and friends are invited to attend our CREEK Kid celebrations to honor our students! Please check in at the main office to receive a visitor badge.

#### **DISCIPLINE LADDER & MATRIX**

We use **DPS' Discipline Ladder** and **Discipline Matrix** as a framework for addressing negative student behaviors. These documents are the product of the DPS Discipline Policy, as described in School Board Policies JK & JK-R. In sum, this system encourages staff to examine student offenses against a leveled approach (e.g., Level A, first incident of a minor offense, in which teacher will counsel student and intervention is initiated). Depending on the offense, consequences may range from a reminder by the teacher, to a parent/guardian phone call or meeting, to an in/out-of-school suspension. We want to ensure that consequences for poor choices are appropriate for the action. To this end, teachers may handle discipline in various ways. Please reach out to your child's teacher to understand the classroom policy more fully. Ultimately, our discipline policy has been designed to help our students learn self-control and discipline in a constructive way. It is our hope that throughout the school year, our school-wide focus on positive behaviors will help students make choices that benefit them and their peers. ## **DRESS CODE**

We expect students to come to school appropriately dressed for learning. We ask that students refrain from wearing hats, caps, or sunglasses while in the building during the school day, but they may wear them before school, during recess/brain breaks, and after school (head coverings

are allowed for religious or medical reasons). Shorts and skirts should be a school appropriate length (pants near or at waist level; shorts, skirts, dresses that do not rise above fingertips when hands are extended while resting on each side), and we ask that students refrain from wearing attire with spaghetti straps, halter tops, strapless tops, and other tight-fitting or revealing clothing items. The Denver Board of Education passed a “Zero Gang Tolerance” policy in 1992, which states that no clothing associated with gangs is allowed in any DPS school building. Clothing with derogatory sayings, hate speech, sexual references or language, references to any illegal activity, violent connotations, or political references is prohibited. Students should dress for the weather - especially on inclement weather or field trip days. Please label all outer garments and your child's backpack with their full name.

## EMERGENCY INFORMATION

Parents’/Guardians’ Emergency Information is kept on file through the Parent Portal. Please notify the school office if there is any change in address, telephone number, email address, place of employment, or emergency contact person so that we may be in contact with you at any time if necessary. It is very important for the safety and well-being of your child that you keep this information current. In the case of an emergency, if a parent, guardian, or responsible adult cannot be contacted, the school may call the Denver Police and/or Office of Social Services for assistance.

## ENRICHMENT ACTIVITIES

Westerly Creek offers after school enrichment/extracurricular activities in which parents/guardians can register their children. These activities are offered at the school throughout the school year, generally on a quarterly basis, and are provided by local agencies. Parents/Guardians pay for and register their children in enrichment activities separately from school or Discovery Link registration. Information about enrichment will be posted on-line at the WCE website each year and in the WCE weekly newsletter.

## FIRE DRILLS & EMERGENCY RESPONSE

In a serious emergency, school administrators must decide to lock down, shelter-in-place or evacuate. Practice drills are conducted on a regular basis as required by Denver Public Schools. All schools practice at least one fire drill per month in addition to a lockdown and shelter-in-place drill each semester. Please refer to the DPS Emergency Management website

[ <https://safety.dpsk12.org/o/safety/page/standard-response-protocol> ] for a complete understanding of the drills.

**FIRE DRILLS:** Fire drills are required by law and are important practice in the event of a real emergency. Students learn the evacuation path established for each room they occupy. Conduct rules during these safety drills are strictly enforced. All building occupants must move silently and in an orderly fashion to a specified area where they remain until instructed to return to the building.

**SHELTER-IN-PLACE PROCEDURES FOR SEVERE WEATHER:** Severe weather is any weather condition that may cause injury to students and staff or damage to structures. Different types of weather call for different types of actions. Schools will go into shelter-in-place if the threat of severe weather is in the area. Examples of severe weather are:

- High winds
- Thunder and lightning storms
- Hail
- Tornadoes

The Site Administrator will monitor the National Weather Service announcements and will notify staff and students to move away from rooms on the perimeter and go to the designated Inside Safe Assembly Locations as necessary. The Site Administrator will direct students and staff to take the protective kneeling position if indicated.

**LOCK OUT PROCEDURES:** A lockout takes place when a threat has been identified in the area of the school. School administration secures the building and safely shelters all students, staff and visitors INSIDE the school building. All exterior doors are locked to prevent any hazards or threats to enter the school. No entry or exit to the school is allowed during this response. Students and staff are only allowed to move within the building.

Interior doors DO NOT need to be locked.

- Exterior doors are locked.
- NO entry or exit from the building.
- School business and classroom activities continue as normal.

**LOCK DOWN PROCEDURES:** A lockdown takes place when a hazardous threat or a possible hazardous threat has been identified inside of the building or in close proximity of the school. All exterior doors will automatically lock, and students, staff, and visitors are confined to the school. No entry or exit to the school is allowed during lockdowns and there is absolutely no movement throughout the entire building.

- All exterior and interior doors will be closed and locked.
- Signage will NOT be placed on entrance/exit doors.

- “Lock, lights, out of sight” directive will be given to students and staff.
- Lights will be turned off.
- Use of technology (cell phones, laptops, computers, etc.) is prohibited during lockdowns for safety of the students and staff within the building.
- Students and staff will seek shelter out of sight in their classrooms or other designated space in the school.
- Students in the cafeteria will seek shelter on stage behind curtains.
- If students are outside during recess, they will gather quickly and be escorted by staff away from the school to the reunification site (Bill Roberts School).

**EVACUATION:** If it is unsafe for students, staff, and visitors to remain inside the building, they will evacuate to designated evacuation locations on campus or off-site. The most common evacuation is a fire drill.

- All students and staff will exit the school and go to designated locations.
- Everyone will remain outside until the “all clear” message is given.
- If students and staff need to leave school grounds, we will walk or go by bus to our designated off-site emergency evacuation locations.
- Students will be released to parents or guardians who are listed on file and have proper I.D.

**IN THE EVENT OF A SCHOOL EMERGENCY:**

- DO check the DPS webpage for updated information (<http://www.dpsk12.org>).
- DO tune into local TV/radio stations for school news alerts.
- DO check email and phone messages for information regarding reunification with your child.
- DO NOT go to your child’s school. This will create traffic congestion hampering the efforts of first responders.
- DO NOT call your child or your child’s school. Excessive phone calls can jam the phone system and interfere with emergency communications.

## HOMEWORK

In terms of homework, we ask that students work on i-Ready, read books for enjoyment, and play after school. Some grade levels will send home assignments for students to use as a review and for parents to see what students are currently working on.

## FAMILY INVOLVEMENT

WCE parents, guardians, and family members are essential to the success of our school. Parents, guardians, and family members enrich our school with their ideas, interests, talents, and resources. Just as we have high expectations for our WCE staff and students, we have the same expectations for parental, guardian, and family involvement. One of the most important aspects of involvement is communication between the school and the family (please see the **Communication Expectations** section for additional information). It is a parent's/guardian's responsibility to read and manage communications from the staff, room parents/guardians, and PTA. The teachers will provide regular correspondence about classroom activities, important dates, needed classroom help, etc. The PTA will send a weekly email newsletter to all parent, guardian, and family member subscribers through email (or paper copy if requested) outlining school activities, fundraising events, meeting reminders, important dates, and volunteer opportunities. Periodically, room volunteers will contact you about upcoming classroom events and needed help. If you feel you are not getting the information you need, please contact your teacher, room parent/volunteer or the main office to let them know.

We strongly encourage all family members to get involved in their child's classroom and/or school wide. For a full list of current volunteer opportunities, please check out the PTA's volunteer page [ <https://westerlycreek.dpsk12.org/volunteering/> ].

Discovery Link is a licensed childcare program offered at 60 Denver Public Schools to children ECE (age 3) through middle school. Our Mission is to create opportunities for school communities to engage and inspire Denver youth and families. The Vision of the ELCS department is to provide high-quality programming every day at every site. Discovery Link seeks to support social, emotional, and academic learning, increase family participation and community engagement and expand middle school programming. In addition, they will develop a foundation and provide structures for DPS Elementary School Athletics, known as ELCSports, through our after school programming infrastructure. The purpose is to provide high quality educational, recreational and cultural opportunities for children. Discovery Link believes that choice is essential for children's growth and happiness. Discovery Link guides children to solve their own problems by modeling correct behavior and emphasizing clear conduct guidelines. The programs are staffed with qualified professionals trained in the areas of CPR, First Aid, activity planning, and behavior management.

Discovery Link operates at WCE Monday-Friday with the following program components and hours of operation:

- **Early Risers:** 6:30 AM until school start time (8:05 AM)
- **After School:** School release time (3:10 PM) until 6 PM

## BREAKFAST, LUNCH AND SNACKS

**FREE BREAKFAST AT WCE:** Breakfast is provided to all WCE students at no charge. For breakfast before school, enter the building through the main east side doors. Breakfast begins at 7:30 AM and is served until 8:00 AM. Parents, Guardians, or a Family Member need to accompany and supervise their children in the cafeteria until 7:40 AM. Supervision will be provided starting at 7:40 AM for any children still seeking breakfast. Children will need to enter their student ID number to keep track of each breakfast served, but will not be charged. Visit the front office if you do not know your child's student ID number. Parents, Guardians, and Family Members are welcome to join their child for breakfast for a per item charge. When children are finished with breakfast, they need to exit the doors onto the playground and join their classmates outside for the first bell at 8:05 AM.



**LUNCH:** Hot lunch is currently available free of charge for all students. Students have the option of bringing their own lunch to school or purchasing a hot lunch with milk or just milk. For children who bring their own lunch, please write the child's name on the sack or lunch box. Students are expected to eat a healthy, balanced breakfast and lunch. Soft drinks are not allowed in the WCE lunchroom.

**Healthy School Meals Program:**

All students in DPS have access to free healthy, nutritious school meals since the 2023-24 school year thanks to the [Healthy School Meals for All program](#) approved by Colorado voters! While meals will be provided for free to all DPS students through Healthy School Meals for All, families will still need to complete a form to ensure DPS gets full access to available federal funding.

**What this means for families:**

- Please continue to fill out the [You Benefit! form](#) (formerly referred to as the Meals Application). We ask all DPS families to please complete the You Benefit! form during registration each school year. By completing the form, you will help DPS access all available funds to cover the cost of meals and other nutritional programs for students.
- Families who fill out the You Benefit! form may qualify to receive discounted school fees, class materials, bus passes, utilities support and more!
- All household income information provided through this form is strictly confidential and protected by law. Only one form is required for all children in the household. Immigration, migrant, citizenship or refugee status is not required when completing the form.

**SNACKS:** All grades have a designated snack time each day. Parents/Guardians of students in the ECE classrooms provide group snacks on a weekly schedule, which is organized by the teacher or parent/family volunteer at the start of the school year. Any special dietary needs should be discussed with your teacher. In kindergarten through fifth grades, students are responsible for providing their own snack each day. Snacks need to be nutritious. Candy, high-sugar or high-sodium snacks negatively impact students' ability to focus and learn. Students may put these items in their lunch boxes and eat them during the lunch period. If your child has a medical

need for a snack, you will need to provide a statement from your doctor and the teacher will help your child work out and adhere to a routine. Lastly, snacks should not require preparation, cutting, or the use of utensils.

#### **RECOMMENDED SNACKS:**

- Any fresh fruit, ready/prepared
- Any fresh vegetables, ready/prepared
- Granola bars
- Yogurt sticks
- Cheese sticks
- Raisins/Dried fruits
- Apple sauce
- Rice crackers

Please see **Birthdays/Celebrations section** for school guidance on food items during these events.

## **PETS**

Denver City Ordinances prohibit having dogs or other animals on school grounds, the playground, or in the building. This includes pets on a leash or in a carrier. Please respect this ordinance even after school hours and on weekends. We recognize that some dogs are service animals and are exempt from the above policy.

## **RECESS PROCEDURES AND EXPECTATIONS**

After eating lunch, students go outside every day for recess. Please make sure that they are dressed appropriately (including footwear) to be outside. This would include coats, jackets, hats, scarves, gloves, and attire that is appropriate for the various outdoor weather changes during the school day. We are all aware of how fast the weather in Colorado can change, so please ensure that they have the necessary clothing and accessories prior to coming to school each day. The sun is also very intense in Colorado; please make sure your student has sunscreen applied before coming to school.

#### **RECESS EXPECTATIONS:**

Students are expected to be CREEK kids by showing the core values of Compassion, Respect, Engagement, Empathy and Kindness to ALL. This means they are following the rules and procedures and respecting others and school equipment. If they are not living up to expectations, they have a “take a break” spot. A recess coach will debrief with them and send them back to play. If incidents occur on a consistent basis during the same recess, they will be sent to the office.

We want to make sure that recess has a positive impact not only on the development of the students' social skills, but also achievement and learning in the classroom.

### **PLAYGROUND EXPECTATIONS AND RULES:**

Teachers, paraprofessionals, parents, guardians, family members, and children should all become familiar with these rules and expectations.

#### ***General Rules***

- Always walk on the blacktop and run in the grassy areas.
- No climbing on trees or bushes.
- Keep hands and feet to yourself.
- Always use the equipment for its intended use and place it back in the recess cart at the end of recess.
- Always stay inside the designated play area.
- Kindergarten may not go into the field without a teacher.
- Always show good sportsmanship, play by the rules and show good teamwork skills. If not, you will be asked to stop playing that activity for that day.
- Always share the equipment.
- Always report broken equipment, dangerous situations, and injuries to adults on the playground.
- No "play fighting" such as ninja or superhero fighting. Any use of play weapons will result in a visit to the principal's office.
- Students may not enter the building during recess except to use the restroom or for a nurse visit with permission from a recess coach.

### **PLAN OF ACTION FOR BEHAVIORS:**

Students who choose dangerous, disrespectful, or inappropriate behaviors will be asked to change these behaviors by following rules and expectations. Recess violations include disrespect of property, throwing trash on the playground, and improper use of equipment and/or school grounds.

Students are redirected and asked to sit out of the activity and are not allowed to play for an age-adjusted or level of severity adjusted time period.

Students may also be asked to help pick up trash before reentry into activity.

## **SCHOOL NURSE**

We are here to support your student in health and safety needs. Nursing Services promotes optimal physical, social, and emotional wellness of our school community. Our focus is to

enhance the educational process by maximizing and protecting the overall health status of school-age youth.

We believe that good health enables all students to benefit from the education experience leading to productive living and a successful future. School nurses actively promote healthy lifestyle choices, strengthen and facilitate the educational process by improving and protecting children's health status, and are advocates for school age children.

To ensure all your child's health needs are tended to, WCE provides a school nurse five days a week. If a child becomes ill or injured at school, he/she will receive temporary care and first aid, and the parent/guardian will be notified immediately so that the child may be picked up. Please be sure accurate emergency phone numbers are on file.

**Regarding medication,** Denver Public Schools policy states, in accordance with state law, that medication may be dispensed with physician and parent/guardian authorizations at school. The parent/guardian must provide the medication in a separate prescription bottle that stays at school. The bottle must have a prescription label clearly stating the student's name, doctor's name, name of the medication, dosage and time(s) to be taken. ALL medication must be turned into the office and not carried around by students. Please do not send pills or capsules in plastic bags or over-the-counter medications such as cold pills, Tylenol and cough drops. Medications will be stored and locked in the school office and dispensed by the school nurse or office staff. The student is responsible for going to the office/clinic to obtain his or her medication. **If your student needs to have medications while in school, please complete one of the following forms, signed by your Physician, and turn it in to the health office.**

**Regarding immunizations,** Colorado state law requires all students to be fully immunized when entering school. Records must be available showing dates of all required immunizations, as follows:

- Five DPT
- Four Polio
- Two MMR
- Three doses of Hepatitis B for ECE-3rd grade
- One Varicella for Kindergarten

## SPECIALS

Specials programs are an integral part of the school curriculum and whole child development. Specials include Art, Music, XSTREAM (Stem), Drama, and Physical Education. Your child's homeroom teacher can inform you about what the Specials rotation is for their class.

Students participate in a block rotation for Art, Music, Drama, and XSTREAM and will engage in these classes for a two-week cycle before switching to another special. Students have Physical Education on their specified day once per week throughout the whole school year. Please ensure that on Physical Education days, your child wears clothing appropriate for physical activity and tennis shoes (or brings a change of tennis shoes) to protect the gym floor. Students who do not wear the appropriate footwear will not be able to participate in Physical Education for that day.

## TESTING

Denver Public Schools implements assessments throughout the year to help teachers identify how to best support students and promote student learning and progress. Please do not schedule appointments or trips during scheduled testing periods. Testing dates can be found on the WCE school calendar online and will be shared in the Thursday updates closer to testing in the spring.

## TOBACCO-FREE DISTRICT

Denver Public Schools is a tobacco-free district. No tobacco products are allowed on school grounds.

## TOILET TRAINING

All students in the general education classrooms must be completely toilet trained prior to beginning school. Being toilet trained requires the following:

- Children are aware of their need to use the bathroom and can recognize this in a timely manner to make it to the bathroom.
- Children are able to take care of all their toilet needs independently. This includes wiping themselves and being able to completely change on their own should an accident occur.
- Disposable pull-up pants may not be worn at any time and will not be kept in the classroom.

When a child is toilet trained, we understand that an accident (an untimely recognition of need to use the bathroom) may still occur, however; we do not consider the child toilet trained if accidents occur more often than every few months.

In the event of an accidental wetting, children will need to independently change themselves into dry clothes provided by the parent/guardian. Please wash and return these clothes as soon as possible. In the event of a bowel accident, parents/guardians will be called to change their child, if needed. The child will not be allowed to attend school until he or she is able to successfully take care of his or her toilet needs independently. If absolutely necessary, and as a safety precaution, staff members will wear latex gloves when dealing with any bodily fluids. Students with special needs and in our center-based programs are exempted from this policy.

## TOYS AND PERSONAL BELONGINGS AT SCHOOL

Toys, athletic equipment, gadgets, electronic devices, cell phones and makeup are not to be brought to school without teacher permission. If permitted, they need to be clearly marked with the student's name. Please be aware that we will not assume responsibility for lost, damaged, or stolen materials.

## TRAFFIC AND PEDESTRIAN SAFETY & KISS-AND-GO AND PICK-UP PROCEDURES

**DROP OFF PROCEDURES:** WCE has a formalized Kiss-and-Go system that parents, guardians, and family members can use to drop off their children (K-5) in the morning. All ECE children must be signed in by a parent/guardian each day. As a result, ECE children cannot be dropped off in the Kiss-and-Go (but older siblings can). The goal of Kiss-and-Go is to help reduce congestion and keep traffic moving by providing a safe and organized way for students to be dropped off on school grounds. Once a child has been dropped off in the Kiss-and-Go, s/he can proceed to the playground or designated inside day area during inclement weather.

There are two marked loading and unloading areas for Kiss-and-Go:

- **Westside of WCE** by the west entrance/exit on Xanthia Ct. – enter this zone from the south heading north by way of 26<sup>th</sup> St.
- **Eastside of WCE** by the main entrance on Akron St. – enter this zone from the north heading south by way of 29<sup>th</sup> Ave.

Staff, family, and student volunteers will assist with opening car doors and keeping the unloading zones moving. The Kiss-and-Go zones are NOT parking areas, nor should families pull into the

loading zones and leave their vehicles to unload belongings from the trunk or to open the doors for their children (volunteers can assist with these tasks).

**RULES OF KISS-AND-GO:**

1. Pull as far forward into the unloading area as you safely can, even if there is no other car ahead of you.
2. Ensure your child exits your vehicle curbside, not into the street. Please arrange car/booster seats in such a way that they do not impede safe exiting from your vehicle onto the curb.
3. As soon as your child has safely exited the vehicle and your door has been shut, exit the Kiss-and-Go lane so the cars behind you can pull forward. Do not sit and wait for your child to enter the school.
4. Do not leave your vehicle to apply sunscreen to your child, get belongings out of the trunk, etc. These tasks take more time than is appropriate for Kiss-and-Go purposes, and it's best that you park in a designated area and walk in if you have a lot to unload/manage.
5. Do not under any circumstances make a U-turn out of the Kiss-and-Go lanes or pull into the lane facing oncoming traffic. Enter the Westside lane from a south to north direction, and the Eastside lane from a north to south direction. **DO NOT PARK ON THE CURB OPPOSITE THE NORTHSIDE KISS-AND-GO OR UNLOAD CHILDREN ACROSS FROM ANY KISS-AND-GO LANE.**
6. Use the Kiss-and-Go zone that is closest to where your child lines up on the playground or in front of the building. If you have multiple children to drop off (K-5) you can drop them all off in the same zone or move from zone to zone according to their grade.

If you wish to drop off your student without leaving your car, we strongly recommend you use the Kiss-and-Go lanes. Doing so may mean that you'll need to use major arteries to improve traffic flow and that can feel inconvenient. However, using 29<sup>th</sup> Ave, 26<sup>th</sup> St., and Beeler St. to access the school is going to be safer for our community. Particularly on Akron St., it's best to drive in one direction, north to south. This traffic pattern will best facilitate the safe and speedy arrival of all K-5 students. If you wish to enter the building, please park in the east-facing lot on Akron Street or adjacent side streets where parking is permitted.

**PARKING:** Please use good judgment when parking your car during drop-off and pick-up. Parking on both sides of the street isn't prohibited on the perimeter of the school but it does make it extremely difficult for cars to pass from both directions (which is one of the reasons we encourage a one-way traffic flow on Akron St. and Xanthia Ct). Therefore, if you aren't parking in the East lot, we encourage you to park a little further away in order to disperse parked cars and to keep the traffic flowing smoothly and safely on Akron St. and Xanthia Ct. Also, parking is restricted at the parking lot entryways (as signs indicate), because it is difficult and dangerous for cars to get into and out of the lots, as well as for pedestrians to navigate, when cars are parked

too close. Parking is never permitted in the bus zone on the northeast end of the school (morning or afternoon) or in the Kiss-and-Go lanes in the morning.

**DISCOVERY LINK:** Parents/Guardians who are dropping children off at Discovery Link can park in the loading zones on the Northside of the school but must move their vehicles before 8:30am. Parents/Guardians are able to park in the East lot or on the side streets, especially if they feel it will take more than a few minutes to drop off and sign in their child. Parents/Guardians may also park in the Northside loading zones after 4:30pm when picking up children from Discovery Link. If you do not have a child in Discovery Link, you should not park in the loading/unloading zones.

**ADHERENCE TO TRAFFIC RULES:** Parents/Guardians who break the law or who create hazards for our community by not following the traffic and safety rules will have their license plate number, make, and model submitted to Denver Police Department for appropriate ticketing.

**FOR THE SAFETY OF EVERYONE:**

- DO NOT PARK OR UNLOAD IN THE BUS ZONE ON 28<sup>TH</sup> AVE.
- Please drive slowly through all sections of the neighborhood (we recommend 15 mph for added safety).
- Come to a complete stop at all stop signs.
- Stop for pedestrians crossing the street to and from school - there are NO U-turns at intersections or otherwise.
- Do not park and leave cars in loading zones on the east, west, and north sides of school.
- Do not double park for pick-up, drop-off, or otherwise.
- Observe all NO PARKING signs.
- Do not park too close to driveways or parking lot entryways (observe the signs).
- Do not park in front of or close to fire hydrants.
- Do not use alleyways.
- Do not drop off children near the gates in the parking lots. Park your car or use the Kiss and-Go zones to unload.
- Do not park in the Auction Winner reserved spaces in the East and West parking lots. They are reserved for the entire school year for the auction winners and must be available for them within the indicated time frames. Do not park in the reserved spaces during drop-off and pick-up for any reason.
- Observe any crossing guard signals.

Traffic safety is very important! WCE has a lot of children coming and going from school grounds each day. Please help us keep all of our community members safe, especially our children, by obeying all traffic and safety laws and policies. Offending vehicles will be noted and vehicular information submitted to Denver Police Department for appropriate ticketing. We will also have



periodic patrolling of the school grounds to ensure everyone is adhering to traffic laws and policies. Tickets will be issued accordingly.

**PEDESTRIAN SAFETY:** Please also educate your children about pedestrian safety when on school grounds or walking/riding to school.

1. **Always use crosswalks.** Stop at the end of any sidewalk and look both ways before crossing the street or follow the signal of crossing guards. Also, be careful when crossing alleyways.
2. Walk bikes/scooters when on school grounds, including the perimeter of the building.
3. Please always be aware of your surroundings and of the vehicles driving around the school. Do not dart into the street or parking lots. Stay on sidewalks and grassy areas. Never walk in the middle of the street or parking lot.
4. See **“Wheels at School”** section for additional information about bike and scooter riding on school grounds.

**PICK-UP PROCEDURES:** In the afternoon, your child will be dismissed as appropriate to Discovery Link, their dismissal area, or their bus. Children who walk home or are picked up by a parent or guardian will gather where they line up in the morning. Teachers will only dismiss a child to the approved person designated to pick him/her up. Parents/Guardians must notify their child’s teacher in advance regarding any changes to who is allowed to pick up their child or if there are changes to their normal dismissal procedure.

## WHEELS AT SCHOOL

If your child rides a bike to school, he or she is responsible for making sure the bike is properly locked up. **Bicycles and scooters must be walked on school grounds, which includes all sidewalks on the perimeter of the school and the grassy or blacktop areas.** Students who ride scooters should ask their teacher where their scooters should be stored. Skateboards and rollerblades are not to be used on school grounds. It is recommended that parents/guardians keep a record of the bike’s/scooter’s description and serial number in case of theft.

Parents/Guardians should encourage children to follow all safety rules established for pedestrians and bikes. This emphasis on safety is also a concern of the school’s staff, and is an important part of our instructional program.

## WCE LINGO

**BOOK IT to the CREEK** – Our biggest fall fundraiser! It launches at the end of the school year and encourages summer reading to prevent “the summer slide,” so our students are prepared when they return to school. We hope it establishes reading as a fun habit since kids choose what they read. It also allows family and friends to sponsor our young readers and support WCE.

**BOOK IT or BITTC** – Abbreviation for Book it to the Creek: “Book It” is heard in the halls of WCE in the late spring through fall months; BITTC is often shorthand used in emails or weekly e-blasts.

**Bridging the Gap** – Term we use to “bridge the gap” between DPS funding and the extras we want for our students at the school. “Bridging the Gap” is what we call our Annual Fund campaign since it is direct giving that helps to provide that extra funding.

**Creek Kids** – Creek Kids are one student from each class that is recognized for demonstrating the Creek Kid Character Values and/or Personal Success Factors that the school is focusing on that month. Creek Kids are chosen weekly and announced on Friday mornings.

**Creek Kid Assembly** - A monthly school-wide ceremony that recognizes all the students in each class that were named Creek Kids for that month. Family members are invited to attend!

**Creek Kid Character Values** – Compassion. Respect. Empathy. Engage. Kind. [CREEK]

**CSC** – The Collaborative School Committee (**CSC**) is the decision-making body for Westerly Creek Elementary. It is composed of the Principal, three teachers, three parents, and one community representative.

**Discovery Link** – Provided by DPS, Discovery Link offers quality programming before and after school, during school breaks, and on school dismissal days at over 40 sites across the district, including Westerly Creek Elementary.

**DPS** – Abbreviation for Denver Public Schools, which is WCE’s school district.

**Enrichments** – After school activities that community members provide at the school. There are three sessions throughout the year with different enrichment activities. Families can sign their student up for an additional fee.

**GAP Parties** – Small gatherings of WCE parents that come together socially and raise funds to “bridge the gap” between DPS funding and the grant that the PTA commits to Westerly Creek.

**i-Ready** – Online computer tool that offers programs that help educators teach, assess and assign work to address the diverse needs of our students in subjects like reading, mathematics, intervention, test prep and more. Many WCE teachers use i-Ready in the classroom and for at-home assignments.

**PTA Auction** – The PTA Auction is one of WCE’s largest fundraisers. Parents, teachers, friends and family are invited to attend and participate in our silent and live auction. It is a super fun evening of raising funds to support WCE.

**Restorative Justice** – Restorative Justice is a theory of justice that focuses on mediation and agreement rather than punishment.

**Restorative Approaches** – Restorative Approaches are the three pillars of restorative justice mediation which focus on the harm done, who was impacted by the harm, and how the harm can be repaired. DPS embraces and encourages the use of restorative approaches as a means of dismantling historic and systemic disciplinary practices that have disproportionately suspended, expelled, and contributed to the pipeline to prison, particularly impacting students of color.

**Mindful Minute** – Students are asked to take a silent minute of being still in either meditation or just with their thoughts to calm their bodies and mind before such specials.

**Paras** – Short for paraprofessionals, they assist our full-time teaching staff in the classroom. Much of our PTA fundraising initiatives go towards providing paraprofessionals at WCE. These paras help keep our student-to-teacher ratio lower and provide help in the classroom.

**Personal Success Factors (PSFs)** - As a school community, we are learning how to embed character into routines by naming, modeling, teaching, and building an understanding of the Personal Success Factors: Growth Mindset, Social Intelligence, Gratitude, Zest, Optimism, Curiosity, Self-Control, Grit, and Purpose.

**Pool-to-School** – This annual tradition of walking together as WCE families to say goodbye to summer kicks the school year off right! On the first day of school, and families are invited to meet at the Aviator Pool on E. 28<sup>th</sup> place and walk together to Westerly Creek Elementary.

**PTA** – Parent Teacher Association. All parents and teachers are invited to join the PTA, and membership meetings occur every other month on the second Tuesday of the month.

**Quiet Wolf** – Named for our mascot, the quiet wolf is a hand signal that teachers and students hold up to symbolize that we need quiet and listening ears for the speaker.

**Specials** – The WCE term for Extracurricular Classes that our students rotate through every 14 days. These include Art, Physical Education, Drama, Technology or xSTREAM, and Music.

**Spirit Fridays** – Every Friday! WCE administration and students are encouraged to wear their spirit wear gear and show their school spirit.

**Turkey Trot** – A WCE tradition celebrating the fall. Parents are invited to join their kids at the school and watch them chase the Turkey around the school grounds and enjoy fall festivities.

**WCE** – Abbreviation for Westerly Creek Elementary. Go Wolves!

**WCEats** – Held throughout the school year, these “restaurant nights” are fun community events where you can dine-in, take-out or get delivery from participating restaurants who then return a portion of the sales to WCE. We try to host at least one a month during the school year.

**WCE Family Update** – The weekly email from WCE that is sent each Thursday. Filled with important reminders and upcoming events at school as well as within the community, this is one of the key communication channels for the school. Please contact the front office if you are not receiving it.

**Wolf Den Welcome** – Our annual “Welcome back!” event that usually happens the Thursday afternoon before the first day of school. The school administration and PTA will share important information about WCE. Students learn their classroom assignments and can meet their teachers and see their classroom before the start of school. And we have LOTS of treats and fun for kids out on the blacktop, weather permitting.

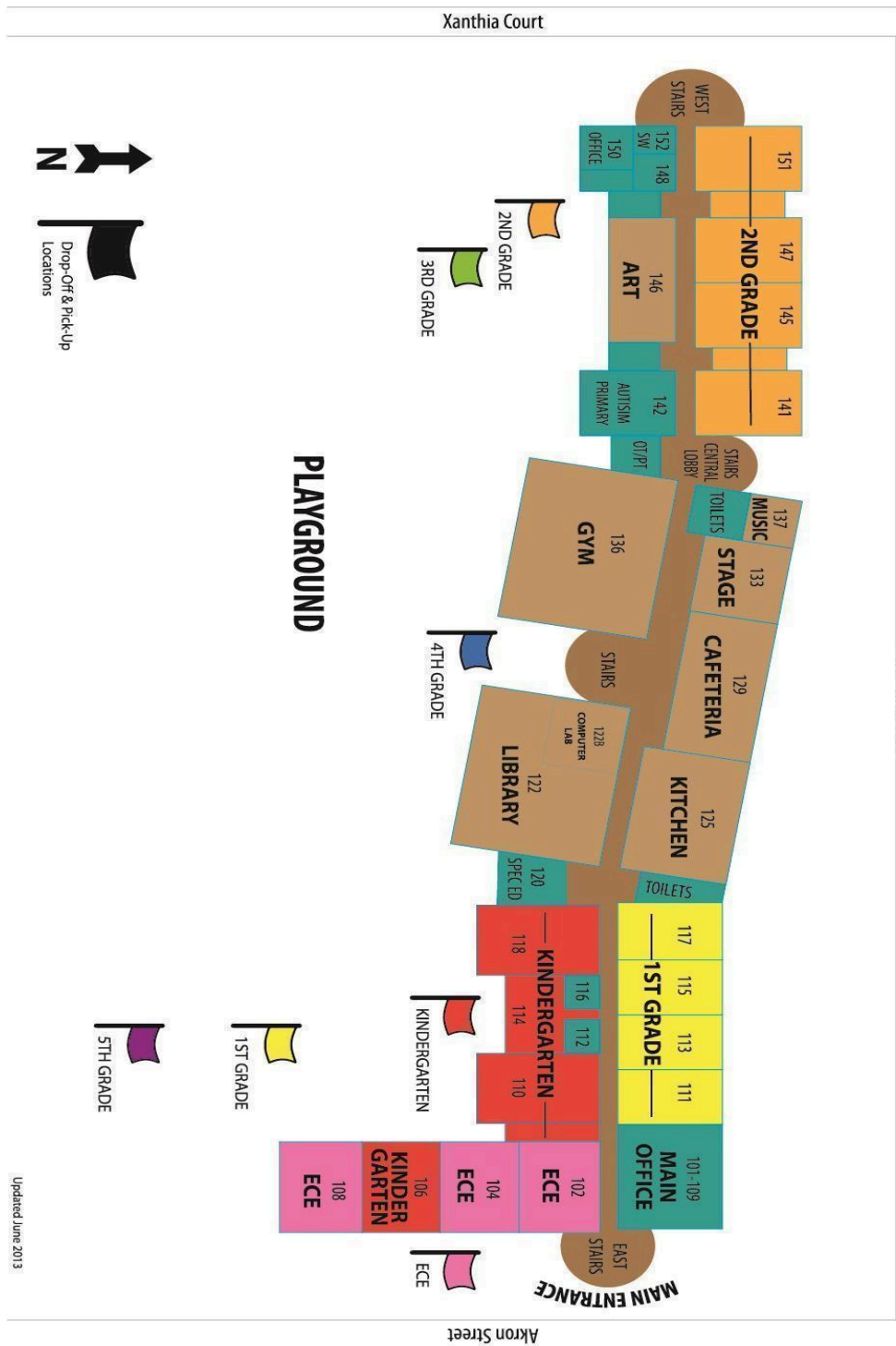

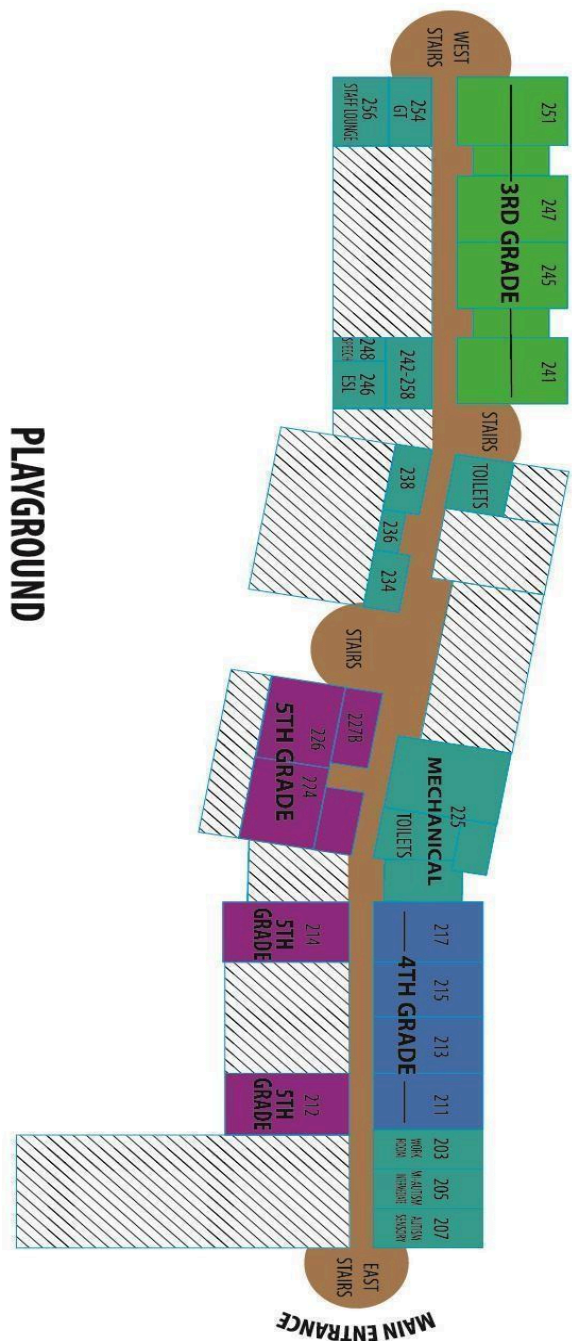
