Discuss and take appropriate action to consider the second reading of Ordinance No. 2016-06 an ordinance of the City of Edna, Texas, amending the City Code of Ordinances, Chapter 2, "Animal Control," Article 2.02, "Dogs," by revising Section 2.02.002, "Vicious or Dangerous Dogs," in order to adopt the provisions of Section 822.0422, Texas Health and Safety Code, to provide for the reporting of an incident involving a dangerous dog to municipal court and the delivery, seizure, impoundment and disposition of such dogs; providing for conflicts, severance, effective date and proper meeting.
5. Discuss and take possible action to consider the second reading of Ordinance No. 2016-07 an ordinance of the City of Edna, Texas, amending the City Code of Ordinances, Chapter 3, "Building Regulations," Article 3.04, "Manufactured Homes and Mobile Homes," by repealing Section 3.04.011, "Accessory Building"; amending and relocating Section 3.04.014, "Variances," to Chapter 14, "Zoning"; amending the notice requirement therein and for other zoning public hearings from 500 feet to 300 feet; by specifying that the Planning and Zoning Commission shall serve as the City's Board of Adjustment; by specifying the requirements for public of notice for public hearings related to zoning; by deleting certain references to a "Board of Adjustments"; assigning the hearing of requests for variances to the Planning and Zoning Commission; providing for findings of fact, severability, repealer, effective date and proper notice and meeting.
6. Discuss and take appropriate action on the Jackson Central Appraisal District Certification of 2016 Appraisal Roll for City of Edna.
7. Consider payment of current bills.
