FY 2026-27 SCHOOL ALLOCATION STANDARDS

I. Budget Cycle

The initial staffing levels provided at the onset of the budget cycle in February preceding the budgetary year will be based upon the Jefferson County Board of Education standards provided herein fulfilling the March 1st statutory deadline. In March, schools will submit their requested changes of staff, based upon SBDM decisions, to Finance and Human Resources. An enrollment adjustment will occur at the start of the new school year based upon changes in enrollment projections within the statutory deadline of September 15th.

II. Operational Supplies

For FY 2026-27, the Base SEEK will be \$4,586; therefore, the **Section 6 per pupil funding amount was \$160.50**. Jefferson County Public Schools will allocate to each council a per-pupil amount based on prior year Average Daily Attendance (ADA) or new-year enrollment projection, whichever is greater. The per-pupil amount for all schools is established in the state's biennial budget in accordance with 702 KAR 3:246, Section 6, subsection 1 - "School councils shall receive a minimum allocation of three and one-half (3 ½) percent of the statewide guaranteed base funding level for Support Education Excellence in Kentucky (SEEK) based on prior year final average daily attendance."

III. Non-Instructional Operational Resources

The District will continue to analyze the adequacy of the non-instructional operational codes in accordance with 702 KAR 3:246, Section 6, subsection 3 - "Allocations for operating expenses, including utilities, or health and safety requirements of schools shall not be included in the allocations required by Sections 4, 5, 6, or 8 of this administrative regulation or this section. If funds are given to a school for these purposes, the funds shall be distributed in a separate fashion. This regulation is fulfilled by the Jefferson County Board of Education by allocations provided in non-flex codes ending in 900XA. Additionally, custodians and custodial supplies are centrally managed by the *JCPS Operations* division.

IV. Classroom Teacher Allocations

Regular classroom teacher allocations satisfy the maximum class size requirements of KRS 157.360. The allocation formulas also accommodate Article 12 of the teacher planning and teacher load agreements of the JCBE-JCTA Contract as well as diversity of scheduling options, such as special areas, related arts, and electives.

V. Enhanced Improvement Zone

Schools identified by the Kentucky Department of Education for additional support due to academic achievement scores (MRI) are identified in JCPS as Enhanced Improvement Zone. The additional support for these schools includes additional resources to be directed at each school.

VI. Section 7

Section 7 funds in JCPS schools will be distributed in accordance with the regulation alternative in 702 KAR 3:246 (7)(1)(c) - "For specific instructional purposes based on student needs identified by the board from disaggregated student achievement data. Money provided under this paragraph shall be used by the council to address only the identified needs." The district satisfies Section 7 with strategic allocations for every elementary, middle and high school including:

The district provides every school with a minimum of **\$35 per pupil for curriculum** (textbooks or other instructional resources).

Financial support is provided to schools based on the number of students qualifying for free- or reduce- lunch at a rate of **\$25 per pupil for elementary, \$30 per pupil for middle school, and \$36 per pupil for high school**. These funds are assigned to a school-specific account, xxx1727 0675 900XA.

All comprehensive elementary, middle and high schools receive supplemental funding in accordance with the Board-approved **student-weighted formula** in Section VII of this document. **JCPS Need Index** will be utilized at the determination of the school Council.

Enhanced Support Zone Schools

Zone Leadership will distribute the following positions to best support schools in the zone.

- Permanent Auxiliary Teacher / In-School Security Monitor (44 total positions)
- Future Sate Funds – Teachers Class Size Reduction (30 positions)

VII. JCPS Needs Based Index: Student-Weighted Formulas

The Board is committed to providing additional funding to schools based on educational risk factors. Many of these additional supports are centrally managed for both efficiency and consistency of support across the district. However, for a district the size of JCPS, local school leadership must also have flexibility in the use of their allocations as well as the additional funds provided. The strategy and formula for the allocation of funds is prescribed for each instructional level (elementary, middle and high) within the School Allocation Standards. Funds will be determined based on a weighted formula of student demographics as prescribed below.

JCPS Needs Index

The JCPS Needs Index has been well established for over a decade and has consistently demonstrated a strong correlation with our students of color and the academic achievement needs of children and schools:

$$\text{JCPS Needs Index} = 0.5 (\%FRL) + 0.3 (\%Mobility) + 0.15 (\%ECE) + 0.05 (\%ML)$$

The JCPS Needs Index is not a reflection of the importance of each demographic, nor does it describe the magnitude of services to be prescribed. This index is simply one of many lenses used by JCPS to provide a view for understanding and supporting our schools.

Definitions

- **Free or Reduced Lunch:** Students who qualify for educational benefits for either free or reduced lunch.
- **Mobility:** Students who move JCPS residence after the start-of-year headcount. Due to the fluid nature of this mobility index, the JCPS Needs Index is calculated using the prior three-year average.
- **ECE:** Students who meet any ECE disability category.
- **ML:** Students who qualify for ESL services.

VIII. Elementary Schools Standard Allocation

Elementary Schools Classroom Staff - Kindergarten through Fifth Grade

The teacher allocations for Kindergarten and Grades 1-5 will be based on a **24 to 1** student-to-teacher ratio. Kindergarten instructional assistants will be allocated at a **24 to 1** student-to-teacher ratio at the Kindergarten level. The allocations established provide sufficient staffing for each teacher to have time for the contractual planning period. Individual class size will vary by grade level dependent upon specific enrollment, homeroom assignments, class schedule, space usage, and council decisions.

Special areas (itinerant) teacher allocations will be provided as a 0.14 teacher allocation for every regular classroom teacher allocation. The **0.14 special areas teacher allocation** will ensure:

- Allocations to support the general art and music experiences for each elementary student.
- Adequate allocation of special area teachers to provide enough classes to allow the contractual planning period for regular education teachers.

Elementary Schools Non-Classroom Staff

All elementary schools will receive:

- **Principal (220 days)**: All schools receive 1.0.
- **Assistant Principals (215 days)**: All schools receive 1.0.
- **School Counselor (195 days)**: District administrative support (non-flex) for school counselors. School enrollment <660 receive 1.0; 660+ receive 2.0.
- **Librarian (194 days)**: All schools with a stand-alone library receive 1.0.
- **Library Media Clerk (6.5 hrs/182 days)**: School enrollment <660 receive 0.5; 660+ receive 1.0.
- **School Secretary I (8 hrs/220 days)**: All schools receive 1.0.
- **School Clerk (8 hrs/187 days)**: All schools receive 1.0.
- **Lunchroom Office Assistant (6.5 hrs/182 days)**: All schools receive 1.0.
- **Instructional Assistant (6.5hrs/187 days)**: All schools receive 1.0.

Elementary Schools Needs Index Funds

The student-weighted formula for classroom teacher allocations will be provided as prescribed in Section VII of this document. These funds may be used for operational funding to address disproportionate student outcomes or to secure staffing to reduce class size, provide targeted academic intervention to close achievement gaps, improve instruction, expand social-emotional support, enrich school-community support, or other strategies as determined by school leadership.

IX. Middle Schools Standard Allocation

Middle Schools Classroom Staff – Sixth through Eighth Grade

Classroom teacher provides for a minimum **26:1** teacher ratio. The allocations established provide sufficient staffing for each teacher to have time for the contractual planning period. Individual class size will vary by grade level dependent upon specific enrollment, homeroom assignments, class schedule, space usage, and council decisions.

Related arts teacher allocations will be provided as a 0.17 teacher allocation for every regular classroom teacher allocation. The **0.17 additional teacher allocation** will ensure:

- Allocations to support the arts, career pathways, world languages and/or other exploratory courses.
- Adequate allocation of related arts teachers to provide enough classes to allow the contractual planning period for regular education teachers.

Middle Schools Non-Classroom Staff

All middle schools will receive:

- **Principal (220 days):** All schools receive 1.0.
- **Assistant Principals (215 days):** School enrollment <450 receive 1.0; 450+ receive 2.0; 700+ receive 3.0; 1250+ receive 4.0.
- **School Counselor (215 days):** District administrative support (non-flex) for school counselors. School enrollment <450 receive 1.0; 450+ receive 2.0; 700+ receive 3.0.
- **Librarian (194 days):** All schools with a stand-alone library receive 1.0.
- **Library Media Clerk (6.5 hrs/185 days):** All schools receive 1.0.
- **School Secretary I (8 hrs/220 days):** All schools receive 1.0.
- **School Bookkeeper I (8 hrs/215 days):** All schools receive 1.0.
- **Records Clerk (8 hrs/187 days):** All schools receive 1.0.
- **School Clerk (8 hrs/187 days):** School enrollment <900 receive 1.0; 900+ receive 2.0; 1300+ receive 3.0.

Middle Schools Needs Index Funds

These funds may be used for operational funding to address disproportionate student outcomes or to secure staffing to reduce class size, provide targeted academic intervention to close achievement gaps, improve instruction, expand social-emotional support, enrich school-community support, or other strategies as determined by school leadership.

X. High Schools Standard Allocation

High Schools Classroom Staff - Ninth through Twelfth Grade

Classroom teacher allocations provides for a minimum **26:1** teacher ratio. The allocations established provide sufficient staffing for each teacher to have time for the contractual planning period. Individual class size will vary by grade level dependent upon specific enrollment, homeroom assignments, class schedule, space usage, and council decisions.

Elective teacher allocations will be provided as a 0.17 teacher allocation for every regular classroom teacher allocation. The **0.17 additional teacher allocation** will ensure:

- Allocations to support the arts, career pathways, world languages and/or other exploratory courses.
- Adequate allocation of elective teachers to provide enough classes to allow the contractual planning period for regular education teachers.

All high schools will receive:

- **Principal (260 days):** All schools receive 1.0.
- **Assistant Principals (215 days):** School enrollment <450 receive 1.0; 450+ receive 2.0; 700+ receive 3.0; 1250+ receive 4.0

- **School Counselor (215 days):** District administrative support (non-flex) for school counselors. School enrollment <450 receive 1.0; 450+ receive 2.0; 700+ receive 3.0; 1000+ receive 4.0; 1250+ receive 5.0; 2000+ receive 6.0

- **Secondary School Attendance Clerk (8 hrs/195 days):** School enrollment <1400 receive 1.0; 1400+ receive 2.0.
- **School Clerk (8 hrs/190 days):** All schools receive 1.0.
- **School Clerk (6.5 hrs/187 days):** All schools receive 2.0.
