1) **General Business**

- a) **Meeting called to order at 6:00 p.m.** by Chairman Danny Klopfer at 5434 S. Tower Drive, Battlefield, MO 65619 in City Hall. The following members were present: Bernie Gerwel, Tim Kelley Sr., David Byrd, Danny Klopfer, Keith Wright, Ron Yancey, and Tim Friel. Staff present were City Administrator Tommy Vanhorn, Building Inspector Tristan Losh, and City Clerk Beth Anne West. Chairman Danny Klopfer noted at the beginning of the meeting that a handout was available that summarized the text amendments for the public and the members to reference.
