

NOTICE OF EXECUTIVE SESSION

Name of Governing Body: Rush County Schools Board of School Trustees

Time and Date of Meeting: Tuesday May 6th 2025 6:00pm

Place of Meeting: Rush County Schools Administration Center

The governing body named above will conduct an Executive Session (one closed to the public, except the Board may admit those persons determined to be necessary to carry out the purpose of the executive session) pursuant to Indiana's Open Door Law (IC 5-14-1.5-5/6, 5-14-1.5-6.1) for the following purpose(s):

- ☐ (1) Meeting is authorized by Federal or State statute.
- ☐ (2) For discussion of strategy with respect to any of the following:
 - ☐ (A) Collective bargaining.
 - ☐ (B) Initiation of litigation, litigation which is pending or has been threatened in writing.
 - ☐ (C) The implementation of security systems.
 - ☐ (D) A real property transaction, including a purchase, a lease as a lessor, a lease as a lessee, a transfer, an exchange or a sale by the governing body, up to the time a contract or option is executed by the parties.
 - ☐ (E) School consolidation.

(By law, "all such strategy discussions must be necessary for bargaining or competitive reasons, and the meeting does not include the competitive bargaining adversaries").
- ☒ (3) For discussion of the assessment, design and/or implementation of school safety and security measures, plans, and systems.
- ☐ (4) To receive information about, and interview, prospective employees.
- ☐ (5) With respect to any individual over whom the governing body has jurisdiction:
 - ☐ (A) To receive information concerning the individual's alleged misconduct: and
 - ☐ (B) To discuss, prior to determination, that individuals' status as an employee, student or independent contractor who is a physician or a school bus driver.
- ☐ (6) For discussion of records classified as confidential by Federal or State statute.
- ☐ (7) For discussion, before any placement decision, of an individual student's abilities, past performance, behavior, and needs.
- ☐ (8) For discussion of an employee's job performance evaluation. This subdivision does not apply to a discussion of the salary, compensation or benefits of employees during a budget process.
- ☐ (9) When considering the appointment of a public official, to do the following:
 - ☐ (A) Develop a list of prospective appointees.
 - ☐ (B) Consider applications.
 - ☐ (C) Make one (1) initial exclusion of prospective appointees from further consideration.
- ☐ (10) The training of Board members by an outside consultant on performance of their role as public officials and/or discussion with or between county officials, Board members, and an outside consultant concerning the performance of Board members.

Any final action taken as a result of a non-public meeting must be taken at a meeting open to the public.

In keeping with the confidential nature of executive sessions, no member of the Board shall disclose the content of discussions that take place during such sessions.

If an Executive Session is interrupted by a scheduled public meeting, it will be adjourned. The uncompleted business will be conducted following the adjournment of the public meeting in a separate executive session for which legal notice is hereby given for the reasons marked above.
