HOW TO EFFECTIVELY COMMUNICATE WITH SCHOOL OFFICIALS

Parents are often discouraged when they attempt to communicate with Central Office administrators and are deferred back to building-based officials to resolve a problem their child may be experiencing in school. To prevent that frustration, parents can become informed about the “Chain of Command”, or where to begin their communication. Many parental questions can be answered easily and completely by communicating directly with the educator in charge of the class or program. Each situation should first be addressed at the level where the initial action was taken, with appeals moving to the next level of the chain of command. The easiest way to communicate is via email; email addresses are listed on the Website Directory page. A phone call would be the next preferable way to communicate.
