- **School Board Update** – School Board Representative, Lauren Shernoff, Leesburg District, addressed the Alliance members. Ms. Shernoff shared what is coming up for the board, collective bargaining resolution, Policy 8655, Personal Devices, Dr. Spence's Post-Entry Plan and the new 2024-25 School Calendar that includes required personal development days for staff to address the new VDOE requirements for instructional staff.
