Brevard Public Schools has reviewed the state's list. Brevard Public Schools has identified and chosen additional certification areas, which are included as well. Certification in a Critical Subject Area alone does not guarantee eligibility. Brevard Public Schools determines Critical Shortage Subject Areas and eligibility criteria on an annual basis and reserves exclusive right to amend any parts, as it perceives the needs of the District. Eligibility includes, but is not limited to, primary teaching function in listed course code, FL DOE certified in corresponding listed subject, teaching corresponding subject for >/99 days and still employed in the same capacity at the time of pay out.*
