# Mark your Calendars for Annual Enrollment!

October 16, 2023 — November 3, 2023



Dear FSRBC Retiree,

It's that time of year again - Annual Enrollment for January 1, 2024 coverage! Annual Enrollment will take place from October 16th through November 3rd, 2023. During this time you are able to enroll, make a plan change, or disenroll. If no plan changes are needed, your current benefits will carry forward in 2024.

# Good News for the 2024 plan year:

- United Healthcare Medicare Advantage Plan rates will remain the same in 2024
- All Prescription Drug Plans (PDP and MAPD) Copays will be \$0 in the Catastrophic Phase.
- NEW Humana Dental 2024 Enhancements:
  - Implants will be an added benefit to the High PPO Plan with a slight rate increase.
- Humana Vision Plan Premiums will remain the same in 2024

Note: If you're enrolled in the Humana Dental High PPO plan and make no changes during Annual Enrollment, you will remain in the High Plan at the increased premium.

If you are pleased with your current plan, <u>no action is required</u>. Any plan change elections must take place during Annual Enrollment from October 16th through November 3rd, 2023 for a January 1, 2024 effective date.
