RE-EVALUATIONS A.K.A EXTENSION OF SERVICES

- Which ELLs need a re-evaluation?
 - Students entering their 4th year from DEUSS (in year 4 students need a re-evaluation meeting)
 - i.e. DEUSS is 03/13/1997
 - Re-evaluation would take place between 02/13/2000-03/12/2000
 - “ELL Committee shall be convened no earlier than 30 days prior...”
 - Students placed in the ESOL Program by an ELL Committee will have a re-evaluation on a yearly basis



How to identify which students are Window 1 versus Window 2 ELLs?

WINDOW 1 ELLS

- WINDOW 1 ELLs are those students with a DEUSS of August 1st through October 1st
 - ACCESS for ELLs (WIDA) and FSA from previous school year
 - 3 data sources

WINDOW 2 ELLS

- WINDOW 2 ELLs are those students with a DEUSS of October 2nd through June 30th
 - Administer screener to obtain current language acquisition data
 - 3 data sources

WINDOW 1 OR WINDOW 2 WHY?

Scenario 1

Student has a DEUSS of 09/30/2000?

Window 1 or Window 2?

Why?

When is their re-evaluation due?

Scenario 2

Student has a DEUSS of 11/24/2005

Window 1 or Window 2?

Why?

When is their re-evaluation due?

EXAMPLE: Re-evaluation Identification Chart 2019-2020 School Year

08/12/19 DEUSS	Year 1
08/12/20	Year 2
08/12/21	Year 3
08/12/22	Year 4 Re-evaluation Due

IMPORTANT COMPLIANCE NOTE

ONLY students with a DEUSS within the first two weeks of school have an extension up to and until October 1st. All other students with a DEUSS date after the first two weeks of school must be conducted within 30 days prior to their DUESS date.

“...if the student’s anniversary date falls within the first two (2) weeks of any school year, the ELL committee may convene no later than October 1 . This process shall be completed annually thereafter. “

Window 1 ELLs

WINDOW 1 ELLs are those students with a DEUSS of August 1st through October 1st

- Use ACCESS for ELLs (WIDA)and FSA info from previous school year
- 3 data sources

Window 2 ELLs

WINDOW 2 ELLs are those students with a DEUSS of October 2nd through June 30th

- Administer screener to obtain current language acquisition data
- 3 data sources
