Food temps from serving line: milk, string cheese, garden salad, salad cups, buffalo chicken salad temped at 39-4 df, ham n cheese sandwiches, fish sandwiches, cheese pizza slices, meatballs, pasta, taco meat, pizza boullis, green beans temped at 158-177 df; hot box set at 169 df. Hot and cold water to all sinks. 3- comp sinks w/ quat, strips onsite, tested at 200 ppm. All coolers below 41 df, freezers below 0 df. Staff bathroom with supplies and sanitary.
