CONTENT AREA SPECIALIST REPORT: July 2022

EARLY CHILDHOOD DEVELOPMENT, TEACHING AND LEARNING

Daily instruction in the Summer Intervention Program during the month of June provided opportunities for developing independence and self-confidence through self-selected activities and building and maintaining relationships with adults and peers, activities to model and reinforce daily routines (e.g., classroom, lunchroom and playground), the use of read alouds with books about going to kindergarten, explicit and systematic instruction in phonological awareness, phonics, language and vocabulary development, and listening comprehension, based on individual child need. (1302.92 Teaching & Learning Environment)

Mentor teachers worked with instructional coaches to prepare for the 2022-23 school year. They spent four days working on activities to strengthening our program as well as preparing to support new teachers.

EARLY CHILDHOOD HEALTH AND WELLNESS

As children registered for school year a review of physicals and immunizations was completed to begin the process of determining child health status. (1302.42 Child Health Status and Care)

The dental hygienist prepared to begin onsite oral health exams beginning in August and continued providing case management to families with children who required follow up oral health care. (1302.42 Child Health Status and Care)

ERSEA/PARENT FAMILY AND COMMUNITY ENGAGEMENT (PFCE)

The program is accepting pre-applications for the 2022 -2023 school year. <u>Pre-applications</u> are available to all interested families via the <u>Head Start website</u>, email or by U.S mail. (1302.13 Recruitment)

Boots on the Ground – Family advocates were employed to ramped up recruitment and enrollment efforts, family advocates were employed to focus on re-enrollment and enrolling new families. Advocates canvased neighborhoods where potentially eligible children could be located. (1302.13 Recruitment)



This year we will be using the ASQ to complete our screenings rather than the BDI. The ASQ will be completed online by the parent. During the parent Home Visit, Open House or Jump Start that each school develops is a perfect time to have parents fill this out. Please plan on having an iPad ready for parents to complete this screening. It will not take more than 10 minutes. Although teachers will not be completing this assessment it will be prudent for teachers AND Family Advocates to devise a system to support parents in getting it done. You will be receiving an email to set up your account and create a username and password. You can find more information at agesandstages.com.

Ages & Stages Questionnaires® (ASQ®) provides reliable, accurate developmental and socialemotional screening for children between birth and age 6. Drawing on parents' expert knowledge, ASQ

has been specifically designed to pinpoint developmental progress and catch delays in young children—paving the way for meaningful next steps in learning, intervention, or monitoring.

Planning Our Time Together

August 8 - 12 Beginning on Tuesday of that week we will designate ONE day that the teaching team and the Family Advocate from each school will work with the coach. The time will be 8:00 to 2:30 with a 30-minute break for lunch. The Coach will be providing Top 5 Foundations, review expectations for implementation of Ready to Advance, Second Step, Daily Scheduling, Setting Goals with Families, TIER 1 checklist review, Needs Assessment and provide direction on Home Visits. Michele McKay or Lynn Gourley will also be present to review our system on requesting support for children, how we utilize ISS plans and review the procedure of taking children through the MTSS process. All teachers, IAs and Family Advocates are required to be with the coach for the full day.
