## **SAC Minutes – December 14, 2022**

### **Our School Vision & Mission**

### **Prior SAC meeting Minutes Review & Approval**

Mrs. Berry motioned to approve the minutes of the November 30, 2022 meeting, and Mrs. Branstetter seconded the motion.

### **Thornton – School Improvement Plan ESSA Subgroup Students with Disabilities (SWD)**

Thornton reviewed the measurable outcome, students with disabilities will increase their Federal Index percentage for ELA by four percentage points, 41% to 45%; this will be tracked by STAR Early Literacy (Renaissance Reports) VPK through first grade and STAR Reading will be used for 2<sup>nd</sup> grade. These reports will offer baseline data that allows teachers and administration to monitor student achievement and growth, literacy proficiency, over the course of the school year. Also, individual subgroup data will be monitored via iReady report group/subgroup (SWD); students in VE self-contained and ESE 1<sup>st</sup> and 2<sup>nd</sup> grades will be monitored by Lexia data.

### **Keane – Youth Truth Survey**

Keane shared that the Youth Truth Student Survey will be given January 3<sup>rd</sup> – January 27<sup>th</sup>; Mrs. Castaldo, media specialist, will spearhead this endeavor. Keane added that parents have the right to have their child opt out of the survey. Also, Keane shared examples from the Youth Truth Survey so that SAC members got a feel for the types of questions being asked. She shared that the survey asks questions about students' overall school experience and the survey takes on average about 15 minutes to complete, additional topic modules add about five minutes each to the survey length and these are limited to two. Mrs. Keane shared that she will receive Youth Truth Survey comprehensive reports, along with indexed qualitative comments.

### **Wedel – Student Holiday Shop**

Wedel shared that all students can shop for a gift to give to a friend/family member. Mrs. Keane added the school community is a huge part of the holiday season for our families in need. She shared St. David's Church donated \$1K in gift cards and Riverside Church donated \$1.3K in gift cards. Mrs. Keane's tennis club donates gifts and gift cards as well.

Mrs. Branstetter added that more tables are needed for the Holiday Shop and Thornton and Keane offered suggestions as to where to locate these for the Holiday Shop.

**Input (Open Forum):**

Ms. Callahan asked that a Reading and Math Spotlight be offered on Class Dojo. She shared that some parents have shared with her that they do not see all information that is posted on Class Dojo; Mrs. Dodd shared that the parent must select school feed to see all Dojo posts. Ms. Callahan also asked that Class Dojo be shared in a school publication to remind parents that this social media platform offers a plethora of school information.

Mrs. Dodd shared that a full-week of literacy activities have been planned for the last full week of January; this week includes a Cookie Monster visit, too.

Thornton shared the next meeting will be January 18 at 3:15.
