# Bylaws for Cape View Elementary School School Advisory Council

# **Establishment of the Committee**

The committee shall be called The School Advisory Council (SAC). It will be composed of the Principal, an appropriately balanced number of teachers, classified personnel, parents and other community members, and any other personnel deemed appropriate by the team and elected by their constituent group. The group shall be made of no more than 49% school board employees, and at least 51% non-school board employees. The team will endeavor to maintain a balance of all areas of the school faculty on the Committee. All members of the team, however, represent the whole school and should keep that in mind when making decisions.

# Purpose

The purpose of the Committee is to address issues which affect the entire school. These should include, but not be limited to, curriculum, discipline, management, staff, services, and maintenance.

# **Committee Elections / Membership**

Their respective peer groups at the school shall elect council members every 3 years representing teachers, education support employees, and parents, in a fair and equitable manner. Ballots will be made up for new nominees. The school community will vote by indicating approval or disapproval of these nominees. Ample advance notice shall be given for nominations of all interested persons in the following categories:

- a. Teachers shall be elected by teachers;
- b. Education support employees shall be elected by education support employees;
- c. Students and parents shall be elected by students and parents;
- d. The Principal will appoint business and community members to achieve appropriate balance.

Members of the School Advisory Council, who miss two (2) regularly scheduled meetings without a satisfactory excuse prior to the scheduled meeting, may be removed from the Council due to lack of attendance. The absences would be discussed, and the Principal and SAC Chair will determine if the member should be removed from the SAC Committee. Vacancies on the Committee will be filled at the next regular meeting. Nominees will be made and seconded and a voice vote taken.

### **Organization**

The Committee will choose at its first regular meeting of the school year, a chairperson, and a secretary.

# **Meetings In-Person**

School Advisory Councils are governed by Florida Sunshine Laws, therefore requiring a quorum (51% or more) be physically present to conduct SAC business. It is permissible for members to attend virtually if the quorum is present and meeting in-person.

#### Sunshine Law



#### Wedel - Comprehensive Needs Assessment

Ms. Wedel shared the "Data Review" Presentation, which included some of the same information that Mrs. Keane shared with the overall school data and FSA data.

The presentation also shared i-Ready Reading and i-Ready Math Data broken down by grade level from the end-of-year diagnostics. The SAC team discussed the comparisons of this EOY i-Ready Data to FSA Data. We noticed that in 3<sup>rd</sup> grade, the i-Ready Reading Diagnostic 3 scores show that the students should have performed better on the ELA FSA if these two tests are supposed to correlate.

Parent Survey Results from 21-22: parents feel welcomed, as though office staff is helpful, that they have opportunities to provide feedback (71%)

Areas to grow - Parents want to attend on campus meetings, family nights, back to school nights, etc. Parents want later events.

Open house will possibly be around the beginning of September. Science will begin to pick up in October.
