Preschool Programs (Head Start/VPK)	Discovery was able to expand the school program to include a Head Start Program for three and four-year old children. Head Start provides comprehensive child development services to predominately economically disadvantaged children and families. Head Start has a special focus on helping preschool children develop early reading and math skills they need to be successful in school. Additionally, Head Start promotes school readiness by enhancing the social, cognitive, and emotional development of preschool children. This is accomplished through the provision of educational health, nutritional, social, and other services to enrolled students and families.
SAC	Discovery encourages parents, teachers, and community members to become involved in the planning, review, and improvement of our programs. Parent, teacher, and community participation in our School Advisory Council (SAC) is essential to our continued improvement and success. All stakeholders are invited to be on the SAC committee and to attend all meetings. All parents, teachers, and community business partners receive an invitation to participate at the SAC meeting, by Blackboard Connect phone, as well as via email and invitation sent in student backpacks. Monthly SAC meetings are currently held the first Thursday of every month at 3:00 pm via Skype. All families are welcome and encouraged to become active members in SAC and asked to provide meaningful input into the development of all plans related to the improvement of Discovery Elementary. The SAC committee provides input regarding the development, implementation, and evaluation of the following: the School Improvement Plan (SIP), the Title I Parental and Family Engagement Plan (PFEP), the Title I Teacher/Parent/Student Compact, the Title I Annual Needs Assessment Survey, and how the 1% of Title I funds reserved for parental involvement will be used. More than 50% of the members of the SAC are parent (non-employee) representatives, with every effort to create a committee representative of our school population. The other SAC members are community members, business partners, and school staff. Minutes from each SAC meeting will be made available to all parents online or parents may request a copy in the front office.

At Open House in September, classroom teachers will hold meetings where information will be presented about the curriculum and academic assessments. Additionally, all stakeholders will be asked to complete a survey in the Spring of 2021 to evaluate the program as a whole and which events/topics they would like to participate in for the following year.
How will the needs of families be assessed to plan future events?	Families are asked to complete a survey at the conclusion of each event. Families will have the opportunity to list any topics/events that will benefit them for the current school year. In addition, all stakeholders are asked to complete a survey in the Spring of 2021 to evaluate the program as a whole and which events/topics they would like to participate in for the following year.



What are the barriers for parents and families to attend workshops/events and how do you overcome these? (transportation, translation, etc)	Discovery will work hard to minimize any barriers by parents and community members. According to numerous surveys, the main barrier that parents have is their work schedule. They are unable to come to events during or immediately after school due to work obligations. To maximize participation, we have added more evening events to meet the needs of all our families. Due to COVID, meetings are virtual and will be recorded for families to access at their convenience. Another barrier is information not being communicated or received by the parents in a timely manner. Discovery is now sending home multiple notices and invitations starting two weeks prior to the event. Discovery is also sending home a monthly calendar, posting information on our website, sending an email and phone call via Blackboard Connect, and posting on ClassDojo to inform all stakeholders of upcoming events. Additionally, Discovery is sending home a translated version when requested by families. Translators are also available during all Title I family events and are made available upon request during any conference between the parent and teacher.
How are flexible dates and times for meetings, events and/or workshops offered? (Give examples)	Discovery Elementary has a strong belief in the importance of parental involvement and offers a variety of meetings at convenient times for families to attend throughout the school year. We have scheduled our SAC meetings for Thursday afternoons at 4:00 pm as indicated in parent surveys. Families are encouraged to contact Discovery to address specific needs/requests to make participation possible. Parent workshops also referred to as "Parent Parties" will be held and materials will be provided to educate families on how to help their child(ren) at home. Families will learn how to monitor their child's progress and work with educators to improve the achievement of their child. These events will be offered at different times, as requested in parent surveys, 8:30 am and 5:00 pm. The evening events will be held on different days and will range over a period of two hours to ensure that parents are able to attend. Due to COVID, meetings are virtual and will be recorded for families to access at their convenience. Discovery will maximize parental involvement and participation in their children's education by arranging school meetings at a variety of times. Teachers will work with parents to meet with them before, after, or during school hours.
How do families who are unable to attend building capacity events receive information from the meetings?	All Discovery staff members will encourage and support families in fully participating in the education of their child. Discovery staff members may direct the parent to a Title I teacher, Literacy Coach or other teacher leaders for help/support. The staff member or Title I teacher will provide event activities and materials at the request of the parent. Additionally, due to COVID, meetings will be recorded for families to access at their convenience.

Discovery teachers, including Title I teachers, will work with all stakeholders to coordinate engaging events that will support the families at home when working with their children and have a better understanding of the curriculum being taught.
