All information is also translated into Spanish. In addition, many individual teachers and grade levels send home class-specific information in the form of newsletters and/or SeeSaw posts.

Letters are sent home with every student that has been taught for four or more consecutive weeks by a teacher who not state-certified in the subject area they are assigned. Attendance at events is analyzed each year to determine if attendance is sufficient and what can be done to increase attendance. Parents and families will provide feedback on events for evaluation and future improvement.
How will the needs of families be assessed to plan future events?	Family needs are assessed through the annual BPS Parent Survey, a Parent and Family Engagement Plan Survey, and Exit Tickets/Surveys at each event.
What are the barriers for parents and families to attend workshops/events and how do you overcome these? (transportation, translation, etc.)	Dr. W.J. Creel Elementary will work hard to minimize any barriers for parents and families to attend. According to numerous surveys, the main barrier is work scheduling. To maximize participation, we have added evening events to meet the needs of all families. Another barrier is information not being communicated or received by the parents in a timely manner. Dr. W.J. Creel Elementary is now sending home multiple notices and invitations at least two weeks prior to an event. We send home paper flyers as well as put a blurb in the monthly newsletter, post on Facebook, SeeSaw, and send FOCUS messages to inform all stakeholders. We will also send home a translated version of all event communication.
How are flexible dates and times for meetings, events and/or workshops offered? (Give examples)	Dr. W.J. Creel Elementary will provide a variety of meetings and events for parents to attend during the year. The results from the BPS Parent Survey, Title 1 Annual Meeting, and other events will be used to plan programs of interest to parents and families, provide flexible meeting dates and times, and meet specific needs of parents and families so that participation is possible. Teachers and other staff members are available during two parent conference nights as well as before school, during planning, or after school. Teachers can meet with parents and families via Zoom or telephone.
How do families who are unable to attend building capacity events receive information from the meetings?	Dr. W.J. Creel Elementary will utilize tools such as the student planner, school website, weekly emails sent by administration, FOCUS, Facebook, SeeSaw, and parent conferences to communicate ways that parents and families can work with their children at home. We also do our best to post any meeting presentations as voice over PowerPoints on our website.
