Call to Order:

A meeting of the Longleaf Elementary School Advisory Council was held through Zoom on May 6, 2020. Co-Chair Eddy Lynn Kledzik called the meeting to order at 4:03 p.m.

Eddy Lynn Kledzik verified that a quorum was met according to Article VIII.

Agenda Adoption:

Farah Shakoorian moved to adopt the agenda.

Minutes:

Farah Shakoorian moved to accept the March minutes.

Old Business:

Eddy Lynn Kledzik reminded members that meeting norms have been established.

New Business:

- Farah Shakoorian shared that SAC funds remain at \$3,507.81.
- Kaylee Whalen presented various types of iReady programs and the amount needed for each. She stated that iReady is aligned with Florida standards. Mrs. Whalen noted that teachers and students currently use and benefit from this program. The following is a list of components she presented:
 - My Path-Reading (online instructional piece): \$8,376
 - Teacher Toolbox (online component for remediation in reading, writing, and math): \$6,460
 - Books for curriculum and toolbox (class sets): \$8,133.48

Discussion then centered on using money from the SAC fund to help defray the cost of the My Path-Reading component of iReady.

 Barb Jaynes moved to vote on using SAC funds for iReady My Path-Reading for the 2020-2021 school year. The motion unanimously carried.

 - Barb Jaynes nominated herself for Secretary.

Open Agenda:

There was a brief discussion about current Bylaws and the possible need to adjust them or change to ones provided by the District, after adjustments. This was tabled until the 2020-2021 school year.
