# WHAT IS TITLE I?

### Title I is a federal grant that:

- Ensures all children have the opportunity to obtain a high-quality education and reach proficiency on challenging state academic standards and assessments
- Provides <u>supplemental</u> funds to school districts to assist schools with high concentrations of poverty to meet educational goals
- Requires schools to train parents on how to support their children academically at home
- Requires schools to train teachers on how to work effectively with parents and families in order to help improve academic achievement
- Requires parents to have an active role in their child's academic achievement

## TITLE I FUNDING

- Districts allocate Title I funds to qualifying schools based on direct certification data
- Title I funds must supplement, not take the place of district funds
- A specified amount of Title I funds <u>must</u> be spent on family engagement. Parent input is critical so schools can provide trainings/events that are relevant to families
- Parents have the right to give input regarding how the school will use its Title I funds


#### WHO DECIDES HOW FUNDS ARE USED?

- Your Title 1 Leadership Team team considers data and feedback collected throughout the school year to write the school's Title I Plan. The team at James Madison Middle consists of Travis Diesel, Cristina Donohue, and Sharon Knight, Vivian Jones, Joshua Drew, and Karen Tabor.
- Use of Title I funds <u>must</u> align with the goals of the School Improvement Plan (SIP).
- Every school has a School Advisory Council (SAC) composed of:
  - parents, teachers, staff, community members, administrators, and students (at middle and high schools)
- The School Advisory Council helps determine how to use Title I funds. <u>Please consider joining we need your voice!</u>

# TITLE I PROGRAMS

- All Title I public schools in Brevard are school-wide programs, meaning Title I funds, along with other local, state, and federal funding sources are used to support <u>all</u> students in the school
- The primary focus of the Title I program is to support the students most at-risk for academic failure
- School identify specific groups of students that need more intensive academic support. These subgroups are shown in the School Improvement Plan (SIP)

## **TESTING**

- Parents/families will be provided information regarding the level of achievement of their child on each state academic assessment that is required by law
- Parents/families must be provided materials to support their child if they are performing below grade level on the state academic assessments in reading and/or math
- Parents/families of students that are identified as substantially deficient in reading based on the state academic assessments must be provided with a "Read at Home" Plan
- To the extent that is feasible, testing information must be translated into a language the parents/families can understand

- Students will take 3 FAST assessments throughout the year one in September, January, and May

### 22-23 PARENT SURVEY RESULTS

- The Parent Survey data indicates that families would want to participate in family nights at Madison related to instruction and engagement.
- In the survey it specifies that about 20% of respondents never received information about activities or meetings on campus.
- Over 50% of respondents indicated that they would like information on how to support learning at home.
- Families indicated that convenient meeting times, more opportunities to share opinions about school issues, and additional information about school issues would aid in them playing a more active role in school decision making.
- A majority of parents felt that online surveys were the best way they could provide input on the school; with 20% in favor of in person meetings, 10% preferring paper surveys, and another 10% desiring phone calls.


