## **Schedule with Details**

Monday, March 4: Summer schedule is live on EFSC website to browse.

### Monday, March 18 - Friday, March 31: EFSC Priority Registration for Summer Begins

For dual enrolled students who have earned 42 credits or more (does not include courses in progress) and BPS students in the Early College program are eligible for priority registration.

### Monday, April 1 – Thursday, April 25: EFSC Regular Registration

All other dual enrolled students who do not meet the priority criteria.

#### Monday, April 8: Summer Dual Enrollment online application deadline

Students new to dual enrollment must have the online application to EFSC completed by this date.

## Tuesday, April 9: Last Early College in-person orientation opportunity

Students interested in joining the Early College Program must attend an in-person orientation (in addition to the online dual enrollment orientation). Orientation dates and locations will be provided upon earning qualifying test scores.

## Thursday, April 25: Dual Enrollment Admissions Deadline

After completing the online application students will be emailed a "Congratulations you have been accepted" letter from EFSC. This letter will contain their EFSC student ID or B# and directions for the following steps: Complete the online dual enrollment orientation AND the initial advising appointment. Both are done in the students' myEFSC portal. The admissions process is not complete until both items are done. VERY IMPORTANT: complete the online DUAL ENROLLMENT orientation, NOT the regular student orientation.

## Thursday, April 25: LAST Day for Summer Term Dual Enrollment Registration

Final deadline for all dual enrollment students to have summer courses registered. Status of registration can be checked in the students' myEFSC portal.

### Monday, April 29 – Thursday, May 3: Add/Drop Window Opens

Dual enrollment students can make approved changes to existing schedules. Must go through high school counselor. Students cannot make changes in the registration area of their myEFSC portal.

#### Friday, May 3: LAST Day for Summer add/drop/schedule changes for all Dual Enrollment Students

Students will be denied changes during the first week of class add/drop unless there is an extenuating circumstance. All changes must go through your high school counselor.
