Barriers include families having multiple children in different grades as well as the inability to get off work multiple time per month to attend meetings. that will be addressed so that families are able to attend will be coordinating the annual meeting with Open House and hosting two times to meet during the evening.

Title III-ESOL *District Coordinator-Anne Skinner	Teachers and staff identify families in need of services. Saturn has a full time ESOL teacher and ESOL Assistant that will be available at parents and families request to translate and provide language services. The ESOL teacher will support students and families with academic as well as non-academic needs such as, but not limited to school guidance and community partnerships. Staff work together with our ESOL teacher to provide translations for meetings and documentation. Communication is strengthened between families, staff, and students through sending home documents in parents' home language and utilizing additional faculty and staff that speak Spanish to assist in communicating with parents.
Students in Transition *District Contact-Ivette Collado	Our school social worker collaborates with the district's homeless liaison to ensure students identified are receiving the appropriate resources and services available. Students and families will connect with community agencies that can assist with transition needs such as housing, food, clothing, and medical assistance, tutoring and transportation.
FDLRS/ESE Services	Students require ESE services the appropriate support through certified ESE teachers, school psychologists, speech pathologists and an occupational therapist, that are available on campus during school hours. Saturn also utilizes the Florida Diagnostic & Learning Resources System (FDLRS) provides diagnostic, instructional, and technology support services to district exceptional education programs and families of students with disabilities.
Preschool Programs (Head Start/VPK)	Saturn's Preschool programs assist families with transitioning to pre-K as well as transitioning from Pre-K into Kindergarten. We provide a safe and smooth transition into our kindergarten program, hosting meetings between district liaisons and parents.
SAC	Saturn's SAC committee will meet each month to discuss various topics related to school growth and student achievement. Input into school-based documents will be solicited from members and attendees and feedback for the betterment of Saturn will be collected.

Parents are also able to request a meeting at any time during the school year to discuss their child progress.

How will workshops/events for families be evaluated to determine their effectiveness?	Workshops/events will be evaluated through family and parent exit tickets and surveys as well as event sign in sheets to determine how many families are taking part in specific events as well as determining future needs of our families.
How will the needs of families be assessed to plan future events?	When planning future events at Saturn, the needs of families will be assessed by desegregating data from exit tickets and surveys, looking at meeting minutes where parent input was given. Conversations with community agencies and business regarding partners regarding family needs will also be taken into consideration when planning events for the school. Saturn will take into consider all input given by families and the community to determine the best and most meaningful way to meet the needs of all families.
What are the barriers for parents and families to attend workshops/events and how do you overcome these? (transportation, translation, etc)	Barriers for parents and families that will be addressed during the 23/24 school year include availability to attend events and language translations. Families that are not able to attend an event will be given the opportunity to set up a meeting where information, materials and guidance can be given. Saturn will also have a Spanish speaking teacher on site at each event to offer translation services to parents and families.
How are flexible dates and times for meetings, events and/or workshops offered? (Give examples)	Parents have the option to request a meeting with their child's teacher anytime throughout the school year. Teachers are available before school, during their planning time and after school to meet with families. Special arrangements will be made for parents to meet with their child's teacher if they are unable to meet during offered times. Saturn will also offer events on different days of the week and at different times.
How do families who are unable to attend building capacity events receive information from the meetings?	Families who are unable to attend building events and meetings can receive information in various ways by call Saturn's front office to request a meeting with administration, requesting that the information given out at the meeting be sent home and or by calling and speaking with the appropriate staff member to be given the information verbally over the phone. Also, materials that are sent home with families at events and meetings can be sent home with students, or parents can request to pick up the material sin the front office.
