

# EFSC/BPS COLLEGIATE HIGH SCHOOL

## 2017 Student/Parent Participation Agreement

The Collegiate High School provides participating students with the opportunity to complete the requirements for a diploma and a university-transfer Associate in Arts Degree (A.A.) by graduation. Your signature indicates that you have read and are in agreement with the following policies and procedures and that you are aware that both parent and student must attend the Collegiate High School Orientation:

1. I understand I will attend classes at EFSC with students of varying ages and experiences and will be subject to the same standards, policies and responsibilities as traditional college students.
2. I understand course content, instruction, academic expectations and educational materials in EFSC courses have been developed for adult students typically aged 18 or older and will not be modified or changed to accommodate younger students.
3. I understand withdrawal from a college course with a grade of W may jeopardize my graduation and completion of my A.A. degree; I understand that I will no longer be eligible for Collegiate High School if I receive a W8 from an EFSC course due to non-attendance or if I am withdrawn from a class for disciplinary reasons.
4. I understand the school counselor is the contact for parents who need information about their student's academic progress at EFSC and that parents may not contact their child's EFSC instructor in person, by phone or by email for this information.
5. EFSC uses the Canvas Learning Management System. I understand that if it is determined that persons other than the student are accessing a student's records in the Canvas classroom, the student will be removed from the class and receive a final grade of "F." While students may have provided written consent for a third party to receive information regarding their educational records, that consent does not permit any other person besides the student to complete or access coursework within the classroom or online setting.
6. I understand I must continuously meet Collegiate High School Academic Standards to remain enrolled in the program, including but not limited to maintaining an overall state cumulative unweighted high school GPA of at least 3.0, earning a GPA of at least 2.0 in college coursework each term, achieve a grade of at least a "C" in each course taken to fulfill a general education requirement, and be on track to receive an A.A. degree by high school graduation.
7. I understand that I must have college ready scores in reading and writing on the ACT, SAT or PERT for initial acceptance into Collegiate High School and a college ready math score no later than the summer prior to my senior year.
8. I understand grades received in EFSC courses become a part of my permanent college and high school transcripts.
9. I understand inappropriate and disruptive behavior will not be tolerated and will result in administrative withdrawal from Collegiate High School and possible loss of dual enrollment eligibility.
10. I understand that cheating including plagiarism is a serious, disciplinary offence at EFSC and students may receive a grade of "F" in the class where the offence took place, as well as losing dual enrollment eligibility.
11. I understand that completion of high school graduation requirements does not guarantee completion of an A.A. degree.
12. I understand that a student must meet all program requirements identified in the EFSC catalog at the time of the student's initial admission to receive an A.A. degree.
13. I understand that under the Statewide Articulation Agreement, A.A. degree graduates are guaranteed admission to one of the public Florida universities. They are not guaranteed admission, however, to the university of their first choice or to the limited access programs within the institution. Limited access programs limit enrollment to a specific number of applicants and have additional entry requirements.
14. I understand I must identify my intended baccalaureate degree program early (by fall of the 11th grade and/or 30 college credit hours) in order to complete the prerequisites for the program within my A.A. degree. I understand that changing my major may prevent my completing the prerequisites by high school graduation.
15. I understand I must complete prerequisites for my intended baccalaureate degree program to be considered for transfer into junior level work in my selected major at a state university.
16. I understand the school district will provide required college textbooks, but it is my responsibility to pay for required consumable materials, e.g. lab manuals, yearly parking permit, the term access fee, graduation application fee and EFSC parking fines/tickets.
17. I understand transportation will be available to 10<sup>th</sup> grade students during the designated Collegiate High School periods at EFSC. Students are responsible for their own transportation when public schools are not in session. I understand 11th and 12th grade students and 10<sup>th</sup> grade students who take courses offered outside the Collegiate High School periods at EFSC are responsible for their own transportation to EFSC.
18. I agree to consult regularly with an EFSC advisor and high school counselor to select courses that meet high school graduation, A.A. degree completion requirements, and program prerequisites for my intended university major.
19. I understand that I must attend my EFSC classes regularly and am responsible for knowing the EFSC attendance policy. I am aware that EFSC instructors may set a more stringent attendance policy, and this will be reflected in their course syllabus. I am also aware that I must follow both the BPS and EFSC Academic Calendars.
