

## **West Shore Jr. /Sr. High School Student Parking Registration**

**Parking on the West Shore Jr. /Sr. High School campus is a privilege extended to seniors, juniors and sophomore students who meet parking permit eligibility. Any student that requests to park their vehicle on campus must register their vehicle with West Shore Jr. /Sr. High School and properly display the current parking permit as required. Each student vehicle operator being permitted to park on campus agrees to be bound to the rules set in the student handbook and all Florida motor vehicle laws.**

***MUST PROVIDE ORIGINAL \*Vehicle Registration- Valid Driver's License- Current Insurance \*\*\****

### ***Parking Rules***

1. Current school year permit to be displayed properly from the rear view mirror.
2. Permit is for registered vehicle only.
3. All traffic signs, markings, speed limits and directional arrows must be obeyed.
4. Directions given by police officers, administrators, and faculty, staff and school officials must be followed at all times.
5. Students will not loiter in the parking lot before, during and after school.
6. With the exception of staff, only vehicles with a valid West Shore Jr. /Sr. High School permit will be permitted to park in the student lot.
7. Vehicles found to be in violation are subject to being towed at the owner's expense.
8. Parents and other non registered visitors may not use the student parking lot a pick up or drop off point, except for athletic events or approved school functions.
9. Any changes to the below listed items must be made with the School Resource Officer within (24) hours.
10. West Shore jr. /Sr High School is not responsible for any car and its contents.
11. Students must park in their assigned parking lot and utilize designated student spaces only.
12. Parking permits are non-transferable, anyone accepting another student's parking permit or transferring their permit to someone else is subject to disciplinary action, including suspension, and the loss of parking privileges.
13. Vehicles are subject to search any time there is reasonable grounds to believe that illegal, dangerous or disruptive items may be found in them.
14. Bumper stickers and decals must be in good taste. Alcohol, Tobacco and sexual references or advertismemtns, etc are not allowed and students may be told to remove them or possible loss of parking privileges may occur.
15. Students are required to provide a current E Mail address so as to be advised of parking changes, violations or any other matters that may pertain to student parking.
16. Students must have administrative approval to go to their cars during the school day.
17. Student parking decals are \$20.00 and \$5 for replacement decals.

**GENERAL GUIDELINES:** Failure to follow these guidelines, rules and regulations can result in administrative warnings leading to monetary fines and loss of parking privileges.

1. All vehicles driven by students and parked in student parking shall be registered with current Florida registration and proof of insurance. Student shall display a current year West Shore Jr/Sr High School issued decal from vehicle rearview mirror at all times.
2. Students shall register and purchase a decal during school registration. The cost of a decal is \$20 and \$5 for replacement decals.
3. Students may register only one vehicle and permit for that vehicle only. If student obtains a new or replacement vehicle, they must submit a new West Shore parking registration form. (Proof of registration and insurance required)

4. Students who have a registered vehicle and find it necessary to drive a temporary vehicle shall report the use of said temporary vehicle to the SRO upon parking on campus. If the vehicle is used more than one school day, the student shall obtain a temporary parking permit from the SRO or Assistant Principal for Facilities.
5. There are a limited number of student parking spaces on campus. Seniors, Juniors, and Sophomores (if space available) will have parking privileges on campus. Students, who were not able to purchase a decal and wish to park on campus, will have their names added to a waiting list. SRO will advise student when space becomes available.
6. Students may only park in their assigned spot.
7. Disobedience and violations can result in fines and loss of parking privileges as outlined in the in Consequences for Violation Section.

**CONSEQUENCES**

- 1st Offense- Warning and parent phone call
- 2nd Offense- \$15 fine and parent phone call
- 3rd Offense- \$25 fine and parent phone call
- 4th Offense- suspension or revocation of parking privileges
- Reckless/Unsafe Driving will result in loss of parking privileges for at least two weeks
