MINUTES

The West Prairie School District #103 Board of Education met on July 27, 2023, at 7:00 p.m., at West Prairie Jr./Sr. High School for a regular meeting. Board members present were: Scott Vogler, Steve Kitch, Jennifer Cerven, Honey Zimmerman, Jake Kreps, and Mitchell Reed. Members absent: David Taulbee.

PLEDGE OF ALLEGIANCE:

The Board and audience stood and recited the Pledge of Allegiance to the Flag.

ANNOUNCEMENTS:

Superintendent Gradert highlighted the letter from former Superintendent Dr. Jonathan Heerboth congratulating the district on the renovation. Principal Heuer introduced new School Counselor Michelle Aurand.

COMMENTS FROM THE PUBLIC:

There were no comments from the public.

CONSENT AGENDA:

Kitch moved and Cerven seconded to approve the minutes from the June 22, 2023 meeting, and the bills. Those members on roll call voting "aye": Vogler, Kitch, Cerven, Zimmerman, Kreps, and Reed. Nays: None. The motion carried.

ADMINISTRATIVE REPORTS:

One FOIA request from Prairie State Wire regarding substitute teacher information was presented.

Principal Heuer announced that Cyclone Camp will be on August 10th and teachers are starting to set up their classrooms.

Principal Spiker announced that the North Elementary has several hires and the building has lots of young energy.

Superintendent Gradert announced around 750 people attended the grand opening of the new Jr./Sr. High School. 400 people were served food. Online registration is up and running and open registration will be August 3, 2023 from 12 p.m to 6 p.m. at the Jr./Sr. High School. The elementary teachers are receiving training for the new reading curriculum. He reported that the Joint Committee will meet regarding the evaluation cycle and the Threat Assessment team will meet August 8, 2023. He also reported that the agreement with Trajectory is still on hold.

PLACE POLICIES ON SECOND READING AND ADOPT:

Zimmerman moved and Reed seconded to place policies 2:80, 2:170, 4:45, 4:100, 5:230, 6:190, 6:240, 7:275, 7:305, 7:330, 8:25, 8:95 on second reading and adopt as presented. Those members on roll call voting "aye": Vogler, Kitch, Cerven, Zimmerman, Kreps and Reed. Nays: None. The motion carried.

FACILITIES UPDATE:

The Facilities committee discussed an overflow parking lot and parking for buses. Superintendent Gradert supplied the board with the AMP proposal for pulling wires for the security cameras. Three vendors came to the pre-bid meeting for the South Elementary bathroom renovation project. August 3, 2023 will be the bid opening. He also reported that signage will be up before the first day of school. Greenhouse proposals will be presented at the September meeting and the additional furniture will be arriving in September as well.

However, a meeting to consider an increase in compensation to a specific employee of a public body that is subject to the Local Government Wage Increase Transparency Act may not be closed and shall be open to the public and posted and held in accordance with this Act. 5 ILCS 120/2 (c) (1).
