CALL TO ORDER

At 7:00 a.m., Mayor Shields declared a quorum present and called the meeting to order.

Motion carried unanimously.

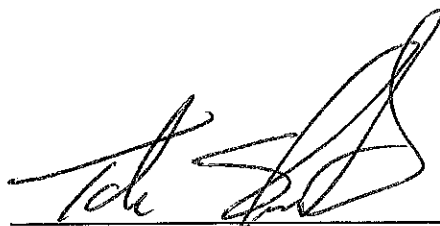
Motion was made by Buchanan to give a 5% salary increase to the City Manager beginning October 1st.

Motion carried unanimously. Murray was not here to vote.

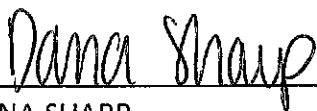
ADJOURNMENT
