MINUTES OF REGULAR CITY COUNCIL MEETING

The City of Spearman, Texas, met in Regular Session in the Council Chambers of City Hall, 30 SW Court, on July 30, 2024, with Mayor Tobe Shields presiding. Council members present: Frank Salgado, Jr., Roger Buchanan, Brian Gillispie and Don Schroeder. Staff present: City Manager Justin Parker, City Secretary Dana Sharp, Public Works Director Mike Olvera, Fire Chief Paxton Heckman. Visitors: Gina Gillispie.

CALL TO ORDER

At 7:04 a.m., Mayor Shields declared a quorum present and called the meeting to order.

CITIZEN REQUESTS AND COMMENTS

DISCUSS AND CONSIDER RESOLUTION NO. 7-24 DESIGNATING CERTAIN OFFICIALS AS BEING RESPONSIBLE FOR, ACTING FOR, AND ON BEHALF OF THE APPLICANT IN DEALING WITH THE TEXAS PARKS & WILDLIFE DEPARTMENT FOR THE PURPOSE OF PARTICIPATION IN THE LOCAL PARK GRANT PROGRAM; CERTIFYING THAT THE APPLICANT IS ELIGIBLE TO RECEIVE PROGRAM ASSISTANCE; CERTIFYING THAT THE APPLICANT MATCHING SHARE IS READILY AVAILABLE; AND DEDICATION THE PROPOSED SITE FOR PERMANENT (OR FOR THE TERM OF THE LEASE FOR LEASED PROPERTY) PUBLIC PARK AND RECREATIONAL USES.

Motion was made by Gillispie to approve Resolution No. 7-24. Second by Buchanan.

DISCUSS AND CONSIDER ORDINANCE NO. 968 PROHIBITING DRILLING OR MINING WITHIN CITY PARK AREAS IN SPEARMAN, TEXAS; AND PROVIDING FOR PENALTY FOR VIOLATING THIS ORDINANCE

Motion made by Buchanan to approve Ordinance No. 968. Second by Salgado.
