Motion carried unanimously.

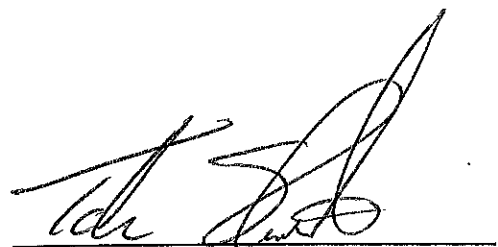
**CONSIDER AND TAKE ACTION DECLARING SURPLUS SCBA'S FROM THE SPEARMAN VOLUNTEER FIRE

Motion was made by Gillispie to approve the transfer to Panhandle Volunteer Fire Department under the condition the receiving department signs a waiver. Second by Salgado.

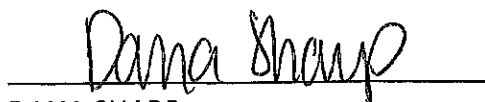
Motion carried unanimously.
