Consider and take official action to adopt Resolution 24-R-07 - **AUTHORIZES THE CITY OF TEXARKANA, TEXAS TO CONTINUE TO BILL THE CITY OF NEW BOSTON, TEXAS THE CURRENT FY 2024 WATER PRODUCTION RATE OF \$1.2606/1000 GALLONS FOR FY 2025 WITH THE FUNDS IN EXCESS OF THE NEW FY 2025 WATER PRODUCTION RATE OF \$1.0895/1000 GALLONS BEING PLACED IN AN INTEREST-BEARING ACCOUNT TO HELP FUND THE UPCOMING PROJECT TO RELOCATE A PORTION OF THE JOINTLY OWNED HIGHWAY 82 WATER TRANSMISSION LINE.**

Consider and take official action adopting Ordinance 24-O-10 - **AN ORDINANCE OF THE CITY OF NEW BOSTON, TEXAS ADOPTING AND LEVYING THE MUNICIPAL AD VALOREM TAX FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025 ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF NEW BOSTON, AS OF JANUARY 1, 2025, PROVIDING REVENUES FOR PAYMENT OF CURRENT EXPENSES AND OUTSTANDING DEBTS OF THE CITY; DIRECTING THE ASSESSMENT THEREOF; AND PROVIDING AN EFFECTIVE DATE.**
