

Clearfield Cyber Service 2026-2027

CASD offers a cyber-school program option for any student residing in the Clearfield Area School District. Clearfield Cyber students are full-time students with the same rights and privileges as -brick-and-mortar students. This includes access to academic support, co-curricular activities, social opportunities, athletics, and the Clearfield County Career and Technology Center. Students enrolled in the Clearfield Cyber Service enjoy several advantages over other, out of district, cyber schools. Clearfield Cyber students can earn a CASD diploma and participate in graduation ceremonies, attend the CCCTC, participate in school athletics and activities, participate in state assessments (PSSA and Keystone), and have access to individual programming with academic support they are familiar with. Clearfield Cyber can provide students with a laptop, printer, ink, and paper at no cost to the family. **Homes must have Internet access to participate in Clearfield Cyber Service.** Clearfield Cyber Services operates through Lincoln Learning Solutions (LLS). LLS provides monthly progress report emails to the primary email address provided on the application. A parent/guardian may also, upon request, be entered as a “mentor” to their student(s) so they can see the student’s progress and grades through their own LLS account. LLS cyber students will still need to check their Microsoft “TEAMS” account for important school announcements. Clearfield cyber students do not receive quarterly report cards from LLS. Instead, they receive a final grade upon **completion** of the class. The grading scale is identical to CAJSHS with 70% being the lowest passing grade.

New for the 2026-2027 school year, Pennsylvania has passed the state budget and included some cyber/charter requirements. There are two items specifically I want you to be aware of. The first is cyber/charter truancy. No cyber/charter will be able to enroll a student that has been deemed habitually truant the prior school year through the court of law. If your student was habitually truant for the 2025-2026 school year, you are not able to enroll a student in any cyber/charter school without going through a court process. Secondly, the state is requiring weekly wellness checks for each cyber student who receives instruction exclusively through the district’s cyber program. The appropriate school counselor, faculty member, or administrator will be setting these up. Wellness checks can be done virtually or in-person.

Clearfield Cyber Service Quick Guide

The Clearfield Area School District (CASD) cyber program operates through Lincoln Learning Solutions (LLS). It provides full-time local students with identical rights, activities, and diploma as traditional brick-and-mortar students.

Program Benefits

- **CASD Diploma:** Students participate in standard graduation ceremonies.
- **Full Access:** Eligibility for CAJSHS athletics, activities, and CCCTC career training.
- **Free Equipment:** District provides a laptop, printer, ink, and paper. (academic year only)
- **Familiar Support:** Access to known local academic support and programming.

Academics & Grading

- **Passing Grade:** Minimum 70% required to pass, matching CAJSHS.
- **Grade Reports:** Final grades issued at course completion, not quarterly.
- **Progress Tracking:** LLS sends monthly progress emails to parents.
- **Parent Mentoring:** Parents can request an LLS account to monitor grades.
- **Announcements:** Students must check Microsoft Teams for school updates.

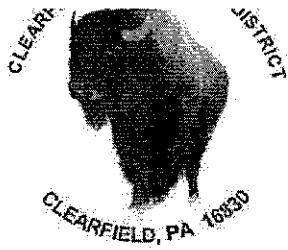
Critical Requirements

- **Home Internet:** Families must provide their own internet connection.
- **State Testing:** Mandatory participation in PSSA and Keystone exams.
- **Truancy Law:** Habitually truant students from previous school year (2025-2026) cannot enroll without court clearance. (new this year)
- **Wellness Checks:** Mandatory weekly virtual or in-person check-ins with district staff. (new this year)
