Dear Parents and Guardians of Crawfordville Elementary School,

I hope this message finds you well. I want to take a moment to address the recent conversations and decisions regarding the rezoning process that impacts our school community. As we all know, rezoning is a complex process—one that requires thoughtful analysis, consideration of many factors, and genuine care for the well-being of our students and families. We deeply appreciate your patience and understanding during this time of transition.

It was truly uplifting to witness the respectful and constructive dialogue at our recent town hall meeting. Your engagement and willingness to listen and collaborate, even amidst difficult decisions, highlight the remarkable strength and unity of our community. Thank you for participating in a way that kept our children's best interests at the forefront.

After careful analysis of the school's capacity, enrollment patterns, and neighborhood demographics, it has been determined that only the addresses east of Crawfordville Highway and south of Dr. Martin Luther King Memorial Road (see attached file) will be reassigned to Medart Elementary School effective the 2026-2027 school-year. This decision was made with the intent to minimize disruption while continuing to provide the best educational environments possible. Per the recommendation, transportation to these addresses will be provided to Medart Elementary School, but no longer to Crawfordville Elementary School.

Any students living at these reassigned addresses, as well as all current out-of-zone students, who wish to remain at Crawfordville Elementary School must complete the district's Out of Zone Request Form in FOCUS by March 14th. The district will follow the School Board's approved plan to enroll these students into available seats. While we anticipate that most students will be able to remain at their current school, it is important to recognize that, due to capacity constraints, some may not be granted continued enrollment. Please know that the policy allows for each case to be reviewed for unique "hardship" circumstances, so we encourage parents and guardians to continue working closely with our staff to ensure that every situation is carefully considered.

We understand that these changes are challenging, and we remain committed to supporting every student and family throughout this process. If you have any questions or need assistance with the Out of Zone Request Form or the review process, please do not hesitate to contact our office.

Thank you once again for your patience, involvement, and steadfast partnership with Crawfordville Elementary School. Together, we will continue building a nurturing and successful school community.

This recommendation will be presented to the Wakulla County School Board at the regularly scheduled meeting on February 17, 2026 for final approval.
