



2 **CITY OF WESTLAKE, OHIO** 3 **ORDINANCE NO. 2025-66:** 4 REDLINED 5 AN ORDINANCE AMENDING SUBSECTION 6 1233.03(d) OF THE ZONING CODE OF THE 7 CITY OF WESTLAKE. 8 9 10 WHEREAS, the Mayor and Director of Planning have recommended that Subsection 11 1233.03(d) of Section 1233.03 "APPEALS AND APPROVALS" of the Zoning Code be amended as to methods of publication; and 12 13 WHEREAS, Council desires to amend Subsection 1233.03(d) of the Zoning Code of the 14 City of Westlake; and 15 WHEREAS, after careful consideration, the Planning Commission of the City of Westlake 16 , 2025, recommended approval of the change to the Zoning Code 17 specified herein; and 18 WHEREAS, pursuant to Article III, Section 13 of the Charter of the City of Westlake, 19 Council provided for and held a public hearing on said code amendment. 20 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 21 WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO: 22 **Section 1:** That Subsection (d) of Section 1233.03 "APPEALS AND APPROVAL" be 23 and the same is hereby amended and as amended shall read as follows: 24 "1233.03 APPEALS AND APPROVALS. 25 (d) Notice of a hearing shall be given in one of two ways: (1) published twice 26 monthly in a newspaper of general circulation no less than four days before the 27 hearing; or (2) by posting a notice conspicuously in the Office of the Clerk of Commissions, on the City Hall Bulletin Board and on the City of Westlake's 28 29 website no less than four days before the hearing." 30 Section 2: That any Ordinances or parts of Ordinances in conflict herewith are hereby 31 repealed.
