6 **AN ORDINANCE SUPPLEMENTING CHAPTER**
7 **141 “ADMINISTRATIVE DEPARTMENT” OF**
8 **PART ONE “ADMINISTRATIVE CODE” WITH**
9 **NEW SECTION 141.12.**

12 **WHEREAS**, the Mayor and Director of Public Service recommend that Chapter 141
13 “Administrative Department” of Part One “Administrative Code” be supplemented to provide for
14 the creation of the position of HVAC Technician.

15 **NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF**
16 **WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

17 **Section 1:** That Chapter 141 “Administrative Department” be and the same is hereby
18 supplemented with new Section 141.12 “HVAC TECHNICIAN”, which as enacted shall read as
19 follows:

20 **“141.12 HVAC TECHNICIAN.**

21
22 **The Mayor shall have the authority to hire an HVAC Technician to meet the**
23 **needs of the City. The HVAC Technician shall work the number of hours as**
24 **designated by the Mayor and it may be either a part-time or full-time position**
25 **as determined by the Mayor and appropriated by Council. A part-time HVAC**
26 **Technician shall be entitled to the benefits granted other part-time employees**
27 **as set forth in Section 141.04(c).”**

29 **Section 2:** That any Ordinances or parts of Ordinances in conflict herewith are hereby
30 repealed.

31 **Section 3:** That it is found and determined that all formal actions of this Council
32 concerning and relating to this legislation were adopted in an open meeting of this Council and
33 that all deliberations of this Council and any of its committees that resulted in such formal action
34 were in meetings open to the public in compliance with all legal requirements including Section
35 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.
