Mouth guards will be provided on the first day. Please bring a thermos with water. Water will be available at all times. Refreshments and snacks will also be provided. Lunch will be given on the last day.

Camp is open to girls who are **upcoming 1st graders through 8th graders** in the Nazareth Area School District (Players will be separated in groups based on age/experience).

Campers will be instructed in the fundamentals of field hockey. Individual skills will be taught, along with team concepts. Stickwork/ball control, passing, receiving, offensive/defensive strategies, and small games will be focused on. The emphasis is on skills, safety, and fun!

The Nazareth Area School District Field Hockey Coaching Staff will conduct the instruction while the current high school players will demonstrate and work individually with the campers.
