## Parent-Teacher-Student Compacts

Eagle Creek and Kent Prairie Elementary schools participate in school-wide Title I Programs. While all students are eligible for services and complete a Title I Compact, program services will look different based on individual academic need. Parents, students, and teachers are involved in completing Title I Compacts. Compacts are provided to families during the Back to School Night. ## Curriculum Materials, Instruction and Assessment

In the past 20 years, research has provided important information about how children learn. Among these findings are:

- Students need to be taught at their instructional level, where the best academic progress is made.
- Students will benefit from extended practice.
- Students need to learn to be able to give rationale for decisions.
- Students need to be taught at a pace that makes sense for their learning style.
- Students need to have a common math language.

Arlington Public Schools utilizes a variety of curricula and assessments in its remedial programs including, but not limited to, the following:

*Early systematic instruction in mathematics and reading*

*Small group instructional level classrooms*

*Math: Delta Math and Math 4 Love*

*Reading: Really Great Reading, Early Interventions in Reading, and Read Naturally Live*

*Student progress is monitored on a regular basis using a variety of assessments, including but not limited to: CORE Assessments,, Dibels 8, Read Naturally Live, iReady & STAR Reading and Math Assessments, and Delta Math*
