The Leggett Independent School District Board of Trustees met in regular session on Monday, October 20, 2025, at 7:00 PM with the following Board Members present: Zach Johnson, Daniel Goodman, Curtis Jefferson, Tommie Collins, Kevin Willson and Armando Diosdado.
