

**Regular Board Meeting
May 18, 2026**

The Leggett Independent School District Board of Trustees met in regular session on Monday, May 18, 2026, at 7:00 PM with the following Board Members present: Curtis Jefferson, Zach Johnson, Daniel Goodman, Tommie Collins, Kevin Willson and Armando Diosdado. Not present Vicki Russell. Administrators present: Jana Lowe, Angela Sales, and Officer Penado from Polk County Sheriff Office.

The meeting was called to order by Curtis Jefferson at 7:00 PM.
