

**Regular Board Meeting
June 24, 2026**

The Leggett Independent School District Board of Trustees met in regular session on Wednesday, June 24, 2026, at 7:00 PM with the following Board Members present: Curtis Jefferson, Zach Johnson, Vicki Russell, Daniel Goodman, Tommie Collins, and Kevin Willson. Not present Armando Diosdado. Administrators present: Jana Lowe, Angela Sales, and Officer Penado & Officer Herrera from Polk County Sheriff Office.

The meeting was called to order by Curtis Jefferson at 7:00 PM.

The certification of public notice and the minutes for May 18, 2026, regular meeting was approved by Daniel Goodman. Kevin Willson seconded the motion. All favored.

We had 1 citizen present. Sharlon Jackson. Ms. Jackson addressed the board about not liking the rule of having to call in advance to be able to speak in citizen participation.
