Driving to and parking at Putnam County High School is a privilege. Failure to comply with the terms of the parking contract may result in the loss of parking privileges, vehicle towing, and/or school suspension.

- 1) Parking passes cost \$25 per year. Vehicles parked on campus without a valid parking pass are subject to booting and towing at the owner's expense.
- 2) Students' permits must be visible and properly displayed on the rearview mirror (number facing out) daily while parked at the school.
- 3) Parking permits may not be sold or loaned to another student. Students who give, sell, or trade their parking pass to another student may have their parking permit revoked and will be subject to punishment deemed appropriate by the administration.
- 4) Students must not exceed 17 excused or unexcused absences (field trips do not count) and 17 late-to-school tardies. Once a student exceeds either of these limits, their parking privileges will be forfeited and the parking spot can be given to another student. No refund will be given for revoked parking privileges.
- 5) Student parking is restricted to the designated parking area on the east side of the school. Students are not permitted to park in the faculty parking lots in front and behind the school.
- 6) All students must have a valid driver's license. A learner's permit will not be accepted. Students must provide a driver's license to the front office when purchasing a parking permit.
- 7) All vehicles driven to campus must be licensed and insured. Students must provide proof of insurance to the front office when purchasing a parking permit.
- 8) Neither the school nor the school district assume responsibility for the security of any vehicle or for any personal property left inside a vehicle.
- 9) Students are prohibited from loitering in the parking lot or visiting the parking lot during the school day without permission from school administration.
- 10) Students who leave campus or take another student(s) off campus without permission will forfeit their parking privileges. No refund will be issued for revoked parking privileges.
- 11) Speeding, or any form of reckless driving on school grounds will not be tolerated. Students are expected to follow all patterns of entry and exit in the parking lot.
