REGULAR COUNCIL MEETING
12/11/2025

The City Council of Hanceville, Alabama, met in public session on December 11, 2025, for a work session beginning at 6:00 PM in the council chambers of city hall with the council meeting immediately following.

City attorney recommends passing a resolution to authorize.

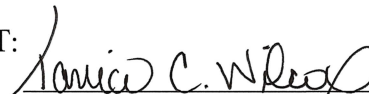
